

History of Changes to Absentee Ballot Eligibility in Connecticut

Issue

Provide a history of changes since 1965 to the law codifying reasons for which electors may vote by absentee ballot in Connecticut, currently <u>CGS § 9-135</u> (amended this year by <u>PA 20-3</u>, <u>July Special</u> <u>Session</u>).

Summary

Since first codifying reasons for which electors may vote by absentee ballot in 1933, it appears the General Assembly has amended the law 26 times. The Legislative Library compiled the legislative histories of the relevant portions of acts from 1965 to 1990. The table below lists these 18 most recent acts and a brief summary of the changes. For an overview of changes to the constitution before then, see this <u>2012 report</u>.

Year	Public Act	Summary of Change
1965	PA 74, S. 1	Implemented the voter-approved state constitutional amendment which added to absentee ballot eligibility where "tenets of his religion forbid secular activity"
1967	PA 678, S. 1	Expanded absentee ballot eligibility to (1) out-of-town college students and (2) religious community members temporarily residing outside of town

1986	PA 86-179	Made technical changes
1987	PA 87-320	Expanded use of absentee ballots to all referenda
2005	PA 05-235	Prohibited anyone from misrepresenting the eligibility requirements for voting by absentee ballot
2012	PA 12-193	Specified that town clerks, registrars of voters, and their staff are among the primary, election, and referendum officials who may vote by absentee ballot if their duties require them to be absent from their polling place during voting hours and made technical changes
2020	PA 20-3 July 2020 Special Session	For the 2020 state election, expanded the reasons for which electors may vote by absentee ballot to include the COVID-19 sickness
