House Bill No. 6250

House of Representatives, April 1, 2025

The Committee on Environment reported through REP. PARKER of the 101st Dist., Chairperson of the Committee on the part of the House, that the bill ought to pass.

AN ACT CONCERNING THE LEVELS OF STAFFING FOR ENVIRONMENTAL CONSERVATION OFFICERS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Section 26-5 of the general statutes is repealed and the
following is substituted in lieu thereof (*Effective from passage*):

3 The Commissioner of Energy and Environmental Protection shall 4 appoint such number of conservation officers as may be necessary for 5 the efficient execution of the duties of the department under section 26-6 6, provided the commissioner shall receive and consider a 7 recommendation for such number of appointments, not less than once 8 every two years, from the Connecticut Conservation Officers 9 Association. Such recommendation shall be: (1) Based on a review of the 10 duties established in section 26-6 and any enhancement of such duties 11 since the issuance of the most recent such recommendation, and (2) 12 submitted by the commissioner to the joint standing committee of the 13 General Assembly having cognizance of matters relating to the 14 environment. The commissioner may supplement the regular

15 conservation officer force by appointing as special conservation officer 16 any employee of the department or any sworn federal law enforcement 17 officer of the United States Fish and Wildlife Service or National Marine 18 Fisheries Service, provided such federal officer shall not be considered 19 an employee of the state and may only exercise such officer's authority 20 pursuant to section 26-6 when working with a full-time conservation 21 officer. The commissioner may also appoint any lake patrolman as a 22 special conservation officer solely for the purpose of enforcing boating 23 laws within such patrolman's jurisdiction, provided such patrolman 24 shall not be considered an employee of the state, and further provided 25 that such patrolman has completed a police training course at a Police 26 Officer Standards and Training Council approved training academy. 27 Notwithstanding the provisions of this section, no such lake patrolman 28 shall carry a firearm while in the performance of such patrolman's 29 duties as a special conservation officer unless the board of selectmen of 30 the town or towns in which the lake on which the lake patrolman serves 31 is located approves such carrying of a firearm, or in the case of any town 32 having no board of selectmen, the lake patrolman obtains the approval 33 of the legislative body of such town or towns in which the lake is 34 located. Each conservation officer shall be certified by the Police Officer 35 Standards and Training Council in accordance with the provisions of 36 section 7-294d not later than one year after appointment. Each special 37 conservation officer shall be certified by the Police Officer Standards 38 and Training Council in accordance with the provisions of section 7-39 294d or complete an equivalent course approved by the Commissioner 40 of Emergency Services and Public Protection. Special conservation 41 officers who are employees of the department shall be entitled to the 42 same benefits to which conservation officers are entitled under the 43 provisions of section 5-142, and such an appointment shall be deemed 44 not to be in conflict with any of the provisions of chapter 67. In addition 45 to their salaries, conservation officers and special conservation officers 46 who are employees of the department shall be reimbursed for all 47 expenses incurred in performance of official duty.

OLR Bill Analysis HB 6250

AN ACT CONCERNING THE LEVELS OF STAFFING FOR ENVIRONMENTAL CONSERVATION OFFICERS.

SUMMARY

By law, the Department of Energy and Environmental Protection (DEEP) commissioner must appoint conservation officers as needed to efficiently enforce the state's environmental laws and regulations.

This bill requires the commissioner to receive and consider conservation officer staffing recommendations from the Connecticut Conservation Officers Association at least once every two years. The association must base its recommendations on a review of conservation officers' statutory duties, including any increased duties since the last recommendation was made.

The bill also requires the DEEP commissioner to submit the association's recommendations to the Environment Committee.

EFFECTIVE DATE: Upon passage

BACKGROUND

Related Bill

HB 7198, favorably reported by the Public Safety and Security Committee, requires the DEEP and emergency services and public protection commissioners to (1) study how to improve the assignment of conservation officers throughout the state and (2) report to the Environment and Public Safety and Security committees by January 1, 2026.
