House Bill No. 6250 As Amended by House Amendment Schedule "A"

Approved by the Legislative Commissioner May 22, 2025

AN ACT CONCERNING THE LEVELS OF STAFFING FOR ENVIRONMENTAL CONSERVATION OFFICERS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (Effective from passage) The Department of Energy and 2 Environmental Protection shall prepare a report concerning the 3 environmental conservation police of the Department of Energy and 4 Environmental Protection. Such report shall examine: (1) The number of 5 conservation police officers and special conservation police officers 6 appointed during the preceding four calendar years, (2) statistics on 7 calls for service by such conservation police officers during such four-8 year period, (3) statistics on the enforcement of all applicable statutory 9 and regulatory provisions by such conservation police officers during 10 such four-year period, and (4) benchmarking of such staffing 11 information and enforcement statistics to other comparable states, as 12 available and appropriate. Not later than February 1, 2026, the 13 department shall submit such report, in accordance with the provisions 14 of section 11-4a of the general statutes, to the joint standing committees

of the General Assembly having cognizance of matters relating to theenvironment and public safety.

This act shall take effect as follows and shall amend the following sections:

Section 1	from passage	New section

Explanation
