***AN ACT ESTABLISHING A WORKING GROUP TO DEVELOP
UNIFORM STATUTORY DEFINITIONS OF "FIRST RESPONDER" AND
"ESSENTIAL WORKER".***

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. (*Effective from passage*) (a) There is established a working
2 group to develop uniform statutory definitions of the terms "first
3 responder" and "essential worker".

4 (b) The working group shall consist of the following members:

5 (1) At least five persons appointed by the chairpersons and ranking
6 members of the joint standing committee of the General Assembly
7 having cognizance of matters relating to public safety and security who
8 the chairpersons and ranking members determine may serve as sources
9 of information and data to accomplish the purposes of the working
10 group;

11 (2) The Commissioner of Emergency Services and Public Protection,

12 or the commissioner's designee;

13 (3) The Labor Commissioner, or the commissioner's designee;

14 (4) The Commissioner of Public Health, or the commissioner's
15 designee; and

16 (5) The Secretary of the Office of Policy and Management, or the
17 secretary's designee.

18 (c) Any member of the working group appointed under subdivision
19 (1) of subsection (b) of this section may be a member of the General
20 Assembly.

21 (d) All initial appointments to the working group shall be made not
22 later than thirty days after the effective date of this section. Any vacancy
23 shall be filled by the appointing authority.

24 (e) The chairpersons of the joint standing committee of the General
25 Assembly having cognizance of matters relating to public safety and
26 security shall select the chairpersons of the working group from among
27 the members of the working group. Such chairpersons of the working
28 group shall schedule the first meeting of the working group, which shall
29 be held not later than sixty days after the effective date of this section.

30 (f) The administrative staff of the joint standing committee of the
31 General Assembly having cognizance of matters relating to public safety
32 and security shall serve as administrative staff of the working group.

33 (g) Not later than January 1, 2026, the working group shall submit a
34 report on its findings and recommendations to the joint standing
35 committee of the General Assembly having cognizance of matters
36 relating to public safety and security, in accordance with the provisions
37 of section 11-4a of the general statutes. The working group shall
38 terminate on the date that it submits such report or January 1, 2026,
39 whichever is later.

This act shall take effect as follows and shall amend the following sections:
