Substitute House Bill No. 7059

House of Representatives, April 1, 2025

The Committee on Transportation reported through REP. BERGER-GIRVALO of the 111th Dist., Chairperson of the Committee on the part of the House, that the substitute bill ought to pass.

AN ACT STUDYING THE DANBURY BRANCH LINE OF THE METRO-NORTH COMMUTER RAILROAD AND CONCERNING THE CONNECTICUT PUBLIC TRANSPORTATION COUNCIL.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (*Effective from passage*) The Commissioner of Transportation 2 shall study the feasibility of (1) operating hybrid trains on the Danbury 3 branch line of the Metro-North Commuter Railroad, and (2) expanding 4 the Danbury branch line to include the town of New Milford. Not later 5 than February 1, 2026, the commissioner shall submit, in accordance with the provisions of section 11-4a of the general statutes, the results of 6 7 such study and any recommendations to the joint standing committee 8 of the General Assembly having cognizance of matters relating to 9 transportation.
- 10 Sec. 2. Section 13b-212b of the general statutes is repealed and the 11 following is substituted in lieu thereof (*Effective July 1, 2025*):
- 12 (a) There is established a Connecticut Public Transportation Council sHB7059 / File No. 404 1

which shall consist of fifteen members, all of whom shall be (1) residents 13 14 who regularly use the transportation services of the New Haven 15 commuter railroad line which includes the New Canaan, Danbury and 16 Waterbury branches of such line, (2) residents who regularly use the 17 transportation services of the Shore Line East railroad line, (3) residents 18 who regularly use the transportation services of the Hartford railroad 19 line, or (4) residents who regularly use public transit services funded by 20 the state. Members shall be appointed as follows: (A) The Governor shall 21 appoint four members; (B) the president pro tempore of the Senate shall 22 appoint two members, one of whom regularly uses public transit 23 services funded by the state and one of whom regularly uses the 24 transportation services of the New Haven railroad line; (C) the speaker 25 of the House of Representatives shall appoint two members, one of 26 whom regularly uses public transit services funded by the state and one 27 of whom regularly uses the transportation services of the Hartford 28 railroad line; (D) the majority leader of the Senate shall appoint one 29 member; (E) the majority leader of the House of Representatives shall 30 appoint one member; (F) the minority leader of the Senate shall appoint 31 one member; (G) the minority leader of the House of Representatives 32 shall appoint one member; (H) the chairpersons of the joint standing 33 committee of the General Assembly having cognizance of matters 34 relating to transportation shall each appoint one member, one of whom 35 regularly uses public transit services funded by the state and one of 36 whom regularly uses the transportation services of the Shore Line East 37 railroad line; and (I) the ranking members of said committee shall jointly 38 appoint one member who regularly uses public transit services funded 39 by the state. Each member shall serve for a term of four years. All initial 40 appointments to the council shall be made by August 1, 2023, and initial 41 members shall serve a four-year term commencing on August 1, 2023, 42 except that any member appointed prior to July 1, 2023, to serve on the 43 former Connecticut Commuter Rail Council and serving on June 30, 44 2023, shall be deemed appointed to serve on the Connecticut Public 45 Transportation Council and may continue to serve until the expiration 46 of such member's term and a successor has qualified. Any vacancy shall 47 be filled by the original appointing authority by appointment for the

unexpired portion of any term. Members of the council shall serve untiltheir respective successors are appointed.

50 (b) Notwithstanding the provisions of section 4-9a, the members of 51 the council shall choose one of the members of the council to be 52 chairperson of the council. A majority of the members of the council 53 then in office shall constitute a quorum for the transaction of any 54 business, and action shall be by vote of a majority of the members 55 present at a meeting. The council shall meet at least once during each 56 calendar quarter and at such other times as the chairperson deems necessary or upon the request of a majority of the members in office. 57 58 Special meetings shall be held at the request of such majority after notice 59 in accordance with the provisions of section 1-225. Any member who 60 fails to attend fifty per cent of all meetings held during any calendar 61 year or who fails to attend three consecutive meetings shall be deemed 62 to have resigned from office. Not later than ten days after a vacancy 63 occurs in the council or the resignation of a member, the chairperson 64 shall notify the appointing authority of such vacancy or resignation.

(c) The Department of Transportation shall maintain records of each
request for information and data received from the council and denote
the status of any such request.

(d) The council shall prepare its budget, if any, and submit its
 budgetary requests to the Department of Transportation and the
 department shall include the council's budgetary request in the
 department's estimate of expenditure requirements in accordance with
 the provisions of section 4-77.

(e) The Department of Transportation shall establish a separate
 Internet web page on the department's Internet web site for the council
 and include on such web page any information as submitted by the
 council. Such information shall include, but need not be limited to, the
 council's meeting schedule, agendas, minutes, reports and resources.

This act shall take effect as follows and shall amend the following sections:

Explanation

Section 1 requires the Department of Transportation (DOT) to conduct a feasibility study on operating hybrid trains and expanding the Danbury branch rail line, as described in the bill, which is expected to result in a one-time cost of approximately \$2 million for consultant support.

Section 2, which is not expected to have a fiscal impact, requires DOT to establish a separate web page on the department's website for the Connecticut Public Transportation Council and to include the council's budget request, if any, in the department's estimate of expenditure requirements.

AN ACT STUDYING THE DANBURY BRANCH LINE OF THE METRO-NORTH COMMUTER RAILROAD AND CONCERNING THE CONNECTICUT PUBLIC TRANSPORTATION COUNCIL.

SUMMARY

This bill requires the Department of Transportation (DOT) commissioner to study the feasibility of operating hybrid trains on Metro-North Railroad's Danbury Branch line and expanding it to include New Milford. The bill requires him to report the study's results and any recommendations to the Transportation Committee by February 1, 2026.

Separately, the bill requires the Connecticut Public Transportation Council to prepare its budget, if any, and submit budgetary requests to DOT. The department must include these requests in the estimate of needed expenditures that existing law requires budgeted agencies to biennially submit to the Office of Policy and Management and the legislature. The bill also requires DOT to create a separate webpage for the council on its website that includes the council's meeting schedule, agendas, minutes, reports, resources, and any other information the council submits.

EFFECTIVE DATE: Upon passage, except the transportation council provisions are effective July 1, 2025.

BACKGROUND

Connecticut Public Transportation Council

By law, the 15-member Connecticut Public Transportation Council is charged with studying and investigating all aspects of the daily operation of commuter railroad systems and state-funded public transit services (e.g., bus transit), monitoring their performance, and recommending changes to improve their efficiency, equity, and quality. The council serves as an advocate for customers of all commuter railroad systems and state-funded public transit services (CGS §§ 13b-212b & -212c).
