#### AN ACT CONCERNING JUVENILE JUSTICE INITIATIVES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (Effective from passage) Not later than July 1, 2025, the
- 2 executive director of the Court Support Services Division of the Judicial
- 3 Branch shall report, in accordance with the provisions of section 11-4a
- 4 of the general statutes, to the joint standing committees of the General
- 5 Assembly having cognizance of matters relating to judiciary and
- 6 appropriations and the budgets of state agencies on the usage of court
- 7 support services for the previous fiscal year and recommendations for
- 8 expansion of such services.

#### **SUMMARY**

The bill requires the Judicial Department to report to the General Assembly by July 1, 2025 on the use of court support services in FY 25 and to make recommendations for the expansion of those services.

### **Court Support Services Division**

The Court Support Services Division, within the Judicial Department, oversees pretrial services, family services, divorce and domestic violence, probation supervision of adults and juveniles, secure juvenile residential centers, and statewide contracted community providers that deliver treatment and other support services.
