House Joint Resolution No. 11

House of Representatives, March 27, 2025

The Committee on Government Administration and Elections reported through REP. BLUMENTHAL of the 147th Dist., Chairperson of the Committee on the part of the House, that the joint resolution ought to be adopted.

## RESOLUTION COMMEMORATING THE TWENTY-SIXTH ANNIVERSARY OF THE CONNECTICUT-TAIWAN SISTER-STATE RELATIONSHIP.

Resolved by this Assembly:

1 WHEREAS, the state of Connecticut and the Republic of China

2 (Taiwan) have enjoyed a long history of friendship and have maintained

3 a fruitful sister-state relationship encompassing cultural, educational

4 and economic exchanges since 1999; and

5 WHEREAS, the state of Connecticut exported 249 million dollars' 6 worth of products to Taiwan in 2023, making Taiwan one of the most 7 important foreign markets for Connecticut, and strengthening a robust 8 bilateral trade relationship as well as fostering a continued collaboration 9 between their respective industries; and

10 WHEREAS, as a full-fledged democracy and robust free-market 11 economy, Taiwan shares with the United States the principles and 12 values that provide a strong foundation for mutually beneficial 13 relations; and WHEREAS, the United States Congress passed the landmark Taiwan Relations Act (TRA) in 1979 to sustain a close bilateral relationship as well as to advance mutual security and commercial interests between the United States and Taiwan, and the TRA, together with the Six Assurances of President Ronald Reagan in 1982, have served as the cornerstone of United States-Taiwan relations and have helped to preserve peace and stability in the Taiwan Strait; and

21 WHEREAS, peace and stability in the Taiwan Strait is crucial to the 22 maintenance of a free and open Indo-Pacific, and Taiwan is an 23 indispensable partner in safeguarding peace and stability in the region; 24 and

WHEREAS, the United States-Taiwan Education Initiative was launched in 2020 to strengthen cooperation on international education and highlight Taiwan's ability to provide instruction in Mandarin, and given Mandarin's designation as a critical language for maintaining national security by the United States, the state of Connecticut welcomes opportunities to advance educational exchanges with Taiwan; and

WHEREAS, Taiwan has signed mutual driver's license recognition pacts with 36 states of the United States since 2013, and more than 25,000 Taiwanese and American citizens have taken advantage of such pacts, and were Taiwan and the state of Connecticut to enter into a driver's license reciprocity agreement with each other, such an agreement would help increase the mobility of international students, business owners and academics from both sides; and

WHEREAS, Taiwan's inclusion in the United States Visa Waiver Program and Global Entry, and the reciprocal travel facilitation enjoyed by United States citizens when visiting Taiwan, allows Taiwan and the United States to develop closer relations and witness rapid growth in all areas of bilateral development; and

WHEREAS, the United States has assisted Taiwan in participating in
the World Health Organization (WHO), the International Civil Aviation
Organization (ICAO), the International Criminal Police Organization

46 (INTERPOL) and the United Nations Framework Convention on
47 Climate Change (UFNCCC), and it will continue to support Taiwan's
48 participation in the United Nations and other international
49 organizations; and

50 WHEREAS, the United States and Taiwan enjoy longstanding and 51 extensive economic ties, including 127 billion dollars in bilateral trade 52 in 2023, making Taiwan the eighth largest trading partner of the United 53 States; and

54 WHEREAS, the advancement of negotiations on the U.S.-Taiwan 55 Initiative on 21st Century Trade and an Avoidance of Double Taxation 56 Agreement (ADTA) with the United States would strengthen bilateral 57 economic and trade partnerships and create jobs, incentivize investment 58 and fortify the resilience of the supply chain for both countries; and

59 WHEREAS, Taiwan supports and wishes to become a full member of 60 the United States-led Indo-Pacific Economic Framework (IPEF), which 61 will help bolster the economic potential of the region by defining shared 62 trade objectives among partners and addressing standards for 63 technology, supply chains, the digital economy and clean energy.

NOW, THEREFORE, BE IT RESOLVED, that the Connecticut General Assembly pause in its deliberations to recognize the twenty-sixth anniversary of the Connecticut-Taiwan Sister-State Relationship, and reiterate its support for a closer economic, educational, scientific and security partnership between the United States and the Republic of China (Taiwan); and

BE IT FURTHER RESOLVED, that the clerks of the Senate and House
of Representatives cause a copy of this resolution to be sent to the Taipei
Economic and Cultural Office in New York.
