The Committee on Environment reported through SEN. LOPES of the 6th Dist., Chairperson of the Committee on the part of the Senate, that the bill ought to pass.

AN ACT ESTABLISHING A SPEED LIMIT FOR LAKE MASHAPAUG IN UNION.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (NEW) (Effective from passage) Not later than April 1, 2026,
- 2 the Department of Energy and Environmental Protection shall adopt
- 3 regulations, in accordance with the provisions of chapter 54 of the
- 4 general statutes, to establish a speed limit of ten miles per hour for all
- 5 motorboats and personal watercrafts operated on Mashapaug Lake in
- 6 the town of Union.

This act shall take effect as follows and shall amend the following
