Senate Bill No. 1175

Senate, March 18, 2025

The Committee on Aging reported through SEN. HOCHADEL of the 13th Dist., Chairperson of the Committee on the part of the Senate, that the bill ought to pass.

AN ACT CONCERNING PUBLIC HEARINGS FOR CERTAIN RATE INCREASES AT ASSISTED LIVING FACILITIES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Subsection (e) of section 19a-564 of the general statutes is
2 repealed and the following is substituted in lieu thereof (*Effective October*
3 *1, 2025*):

4 (e) An assisted living services agency shall: (1) Ensure that all services
5 being provided on an individual basis to clients are fully understood
6 and agreed upon between either the client or the client's representative;
7 (2) ensure that the client or the client's representative are made aware of
8 the cost of any such services; (3) disclose fee increases to a resident or a
9 resident's representative not later than sixty days prior to such fees
10 taking effect; [and] (4) if a fee increase exceeds ten per cent of the
11 previous fee, hold a public informational hearing, not later than thirty
12 days prior to such fee increase taking effect, that provides an
13 opportunity for public commentary, including, but not limited to,
14 commentary by residents, residents' representatives, residents' family

15 members, members of the press and any other member of the public;
16 and (5) provide, upon request, to a resident and a resident's
17 representative the history of fee increases over the past three calendar
18 years. Nothing in this subsection shall be construed to limit an assisted
19 living services agency from immediately adjusting fees to the extent
20 such adjustments are directly related to a change in the level of care or
21 services necessary to meet individual resident safety needs at the time
22 of a scheduled resident care meeting or if a resident's change of
23 condition requires a change in services.

This act shall take effect as follows and shall amend the following sections:

OLR Bill Analysis**SB 1175*****AN ACT CONCERNING PUBLIC HEARINGS FOR CERTAIN RATE INCREASES AT ASSISTED LIVING FACILITIES.*****SUMMARY**

This bill requires assisted living service agencies (ALSAs) to hold a public hearing if any existing fee increases by 10% or more. The hearing must take place at least 30 days before the increase takes effect. The hearing must provide an opportunity for commentary by residents, their representatives or family members, members of the press, or anyone else.

Under existing law, ALSAs must disclose fee increases to residents or their representatives at least 60 days before they take effect. But ALSAs may immediately adjust fees if (1) they are directly related to a change in the level of care or services necessary to meet the resident's safety needs at the time of a scheduled resident care meeting or (2) the resident's condition changes, resulting in a required change in service.
