The Committee on Public Safety and Security reported through SEN. GASTON of the 23rd Dist., Chairperson of the Committee on the part of the Senate, that the bill ought to pass.

# AN ACT CONCERNING THE MEMBERSHIP OF THE CODES AND STANDARDS COMMITTEE.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. Section 29-251 of the general statutes is repealed and the
- 2 following is substituted in lieu thereof (*Effective October 1, 2025*):
- 3 There shall be within the Department of Administrative Services a
- 4 Codes and Standards Committee whose duty it shall be to work with
- 5 the State Building Inspector in the enforcement of this part and the State
- 6 Fire Marshal in the enforcement of part II of this chapter as set forth in
- this section. The committee shall be composed of [twenty-three] <u>twenty</u>
- 8 members, residents of the state, appointed by the Commissioner of
- 9 Administrative Services as follows: (1) [Two] <u>One</u> shall be [architects]
- an architect licensed in the state of Connecticut; (2) [three] two shall be
- 11 professional engineers licensed in the state of Connecticut, [two] <u>one</u> of
- 12 whom shall practice either structural, mechanical or electrical
- 13 engineering [but in no event shall both of such members represent the
- same specialty,] and one of whom shall be a practicing fire protection

15 engineer; [or mechanical engineer with extensive experience in fire 16 protection;] (3) four shall be builders, [remodelers or superintendents of 17 construction,] one of whom shall have expertise in single-family 18 detached residential construction, one of whom shall have expertise in 19 multifamily residential construction, one of whom shall have expertise 20 in residential remodeling and one of whom shall have expertise in 21 commercial construction; (4) [one shall be a public health official; (5)] 22 two shall be local building officials [; (6)] actively engaged in their 23 official duties; (5) two shall be local fire marshals [; (7)] actively engaged 24 in their official duties; (6) one shall be a Connecticut member of a 25 national building trades labor organization; [(8)] (7) one shall have 26 expertise in matters relating to energy efficiency; [(9) four] (8) two shall 27 be public members, one of whom shall have expertise in matters relating 28 to accessibility and use of facilities by persons with physical disabilities; 29 [(10)] (9) one shall be a contractor licensed to perform electrical work or 30 a member of a state-wide electrical trades labor organization; [(11)] (10) 31 one shall be a contractor licensed to perform plumbing and piping work 32 or a member of a state-wide plumbing trades labor organization; [and 33 (12)] (11) one shall be a contractor licensed to perform heating, piping 34 and cooling work or a member of a state-wide heating and cooling 35 trades labor organization; (12) one shall be a contractor licensed to 36 perform the installation of commercial fire sprinkler systems; and (13) 37 one shall be a contractor licensed to perform the installation of 38 commercial fire alarm systems. Each member, other than the public 39 members, shall have had not less than ten years' practical experience in 40 such member's profession or business. The committee shall adopt 41 regulations, in accordance with the provisions of chapter 54, governing 42 the procedure of the committee. Members who fail to attend three 43 consecutive meetings or fifty per cent of all meetings during a calendar 44 year shall be deemed to have resigned. The committee may, within the 45 limits of appropriations provided therefor, employ such assistants as 46 may be necessary to conduct its business.

This act shall take effect as follows and shall amend the following sections:

## OLR Bill Analysis SB 1240

## AN ACT CONCERNING THE MEMBERSHIP OF THE CODES AND STANDARDS COMMITTEE.

#### SUMMARY

This bill decreases the Codes and Standards Committee membership, from 23 to 20, by removing five current members and adding two new ones. It also modifies the required qualifications for certain existing members. The committee, which is within the Department of Administrative Services, works with the state building inspector and state fire marshal to implement the state building, fire safety, and fire prevention codes.

The bill removes the following current committee members:

- 1. one of two licensed architects;
- 2. one of three licensed engineers (specifically, one of the two engineers who must practice structural, mechanical, or electrical engineering);
- 3. a public health official; and
- 4. two of four members of the public.

The bill adds two contractors to the committee, one who is licensed to install commercial fire sprinkler systems and another licensed to install commercial fire alarm systems. Relatedly, it removes a current qualification provision allowing one of the engineers on the committee to be a mechanical engineer with experience in fire protection.

The bill also specifies that (1) the building officials currently on the committee must be local officials and (2) these officials and the local fire

marshals currently on the committee must be actively engaged in their official duties.

Lastly, the bill makes minor, technical, and conforming changes.
