Substitute Senate Bill No. 1370

Senate, March 31, 2025

The Committee on Labor and Public Employees reported through SEN. KUSHNER of the 24th Dist., Chairperson of the Committee on the part of the Senate, that the substitute bill ought to pass.

AN ACT REQUIRING WORKERS PERFORMING OFF-SITE CUSTOM FABRICATION FOR A PUBLIC WORKS PROJECT TO BE PAID PREVAILING WAGE RATES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Subsection (a) of section 31-53 of the general statutes is
repealed and the following is substituted in lieu thereof (*Effective July 1*, 2025):

4 (a) Each contract for the construction, remodeling, refinishing, 5 refurbishing, rehabilitation, alteration or repair of any public works project by the state or any of its agents, or by any political subdivision 6 7 of the state or any of its agents, including, on and after July 1, 2025, each 8 contract for off-site custom fabrication for any such public works 9 project, shall contain the following provision: "The wages paid on an 10 hourly basis to any person performing the work of any mechanic, laborer or worker on the work herein contracted to be done and the 11 12 amount of payment or contribution paid or payable on behalf of each

such person to any employee welfare fund, as defined in subsection (i) 13 14 of this section, shall be at a rate equal to the rate customary or prevailing 15 for the same work in the same trade or occupation in the town in which 16 such public works project is being constructed. Any contractor who is 17 not obligated by agreement to make payment or contribution on behalf 18 of such persons to any such employee welfare fund shall pay to each 19 mechanic, laborer or worker as part of such person's wages the amount 20 of payment or contribution for such person's classification on each pay 21 day." For purposes of this subsection, "off-site custom fabrication" 22 means the fabrication of systems that are fabricated at a site other than 23 the location of a public works project, but are fabricated specifically for 24 such public works project, including plumbing systems, heating 25 systems, cooling systems, pipefitting systems, ventilation systems or 26 exhaust duct systems. "Off-site custom fabrication" does not include 27 components or materials that are stock shelf items or readily available.

This act shall take effect as follows and shall amend the following sections:

Explanation

The bill requires workers performing off-site fabrication for a public works project to be paid prevailing wage rates. This could potentially result in a cost to the Department of Labor (DOL), the State Comptroller-Fringe Benefits account, and the state and municipalities as employers.

The cost to DOL and the Comptroller- Fringe Benefits account is dependent on the potential volume of complaints and investigations brought to the Wage and Workplace Standards Division. As a reference, hiring an additional Wage Enforcement Agent would result in a cost to (1) DOL of \$104,306 (\$97,069 for salary and \$7,237 for

¹The fringe benefit costs for most state employees are budgeted centrally in accounts administered by the Comptroller. The estimated active employee fringe benefit cost associated with most personnel changes is 40.71% of payroll in FY 26.

equipment/overhead) in FY 26 and \$102,806 (\$97,069 for salary and \$5,737 for overhead) in FY 27 and (2) the State Comptroller- Fringe Benefits account of \$39,517 in each FY 26 and FY 27.

Additionally, there is a potential cost to the state and municipalities (for the municipal share of the project cost) as there may be increased contractual costs for these projects beginning in FY 26, to the extent that these projects currently fall below the existing prevailing wage threshold.

The Out Years

The annualized ongoing fiscal impact identified above would continue into the future subject to inflation and the volume of complaints and investigations brought to the Wage and Workplace Standards Division.

AN ACT REQUIRING WORKERS PERFORMING OFF-SITE CUSTOM FABRICATION FOR A PUBLIC WORKS PROJECT TO BE PAID PREVAILING WAGE RATES.

SUMMARY

This bill extends the state's prevailing wage law to cover off-site custom fabrication for a covered public works project. Under the bill, "off-site custom fabrication" is fabricating systems specifically for a public works project at a site other than the project's location. It includes plumbing, heating, cooling, pipefitting, ventilation, and exhaust duct systems, but does not include components or materials that are stock shelf items or readily available.

Generally, the prevailing wage law requires each contract to build, renovate, or repair certain public works projects to have a provision that requires the project's contractors and subcontractors to pay their construction workers wages and benefits equal to those that are customary or prevailing for the same work, in the same occupation, in the same town. Starting July 1, 2025, the bill requires contracts for offsite custom fabrication on prevailing wage projects to include this provision. The prevailing wage law applies to new construction projects costing at least \$1 million and renovation projects costing at least \$100,000.
