# AN ACT PROHIBITING DISCRIMINATION IN SERVICES FUNDED UNDER MEDICAID.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (NEW) (Effective from passage) The Commissioner of Social 2 Services shall require, as a condition of receiving Medicaid 3 reimbursement, that a provider agree, in writing, not to discriminate 4 against any persons whose rights are protected under chapter 814c of 5 the general statutes. The commissioner may withhold Medicaid 6 payments from any provider determined to have engaged in 7 discrimination under the provisions of chapter 814c of the general 8 statutes.

This act shall take effect as follows and shall amend the following sections:

# AN ACT PROHIBITING DISCRIMINATION IN SERVICES FUNDED UNDER MEDICAID.

## SUMMARY

This bill requires the Department of Social Services (DSS) commissioner to require providers, as a condition of receiving Medicaid reimbursement, to agree in writing not to discriminate against people whose rights are protected under the state's human rights statutes. These laws prohibit discrimination based on, among other things, race, national origin, creed, sex, gender identity or expression, color, veteran status, and domestic violence victim status.

The bill allows DSS to withhold Medicaid payments from any provider who is determined to have discriminated in violation of these laws. However, the bill does not specify which entity is responsible for making this determination.

EFFECTIVE DATE: Upon passage

# BACKGROUND

## **DSS Provider Agreements**

Under current practice, providers enrolling in Medicaid must sign agreements with DSS requiring them to, among other things, comply with federal and state anti-discrimination laws as a condition of receiving Medicaid reimbursement.
