Substitute Senate Bill No. 1489

Senate, April 2, 2025

The Committee on Public Safety and Security reported through SEN. GASTON of the 23rd Dist., Chairperson of the Committee on the part of the Senate, that the substitute bill ought to pass.

AN ACT CONCERNING REGIONAL POLICE FORCES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (NEW) (*Effective July 1, 2025*) (a) As used in this section and 2 section 2 of this act:
- 3 (1) "Member municipality" means a town, city or borough that joins4 a regional police force; and
- 5 (2) "Regional police force" means a police department formed by two 6 or more member municipalities that enter into an agreement to combine 7 such member municipalities' police departments.
- 8 (b) On and after October 1, 2025, a regional police force may be 9 formed by two or more municipalities that each have a population of 10 not more than fifty thousand, as determined by the most recent 11 decennial census. Municipalities seeking to form a regional police force 12 shall submit an application to the Commissioner of Emergency Services 13 and Public Protection, in a form and manner prescribed by the

commissioner. The application shall include, but need not be limited to, 14 15 (1) a description of the proposed structure and governance of the 16 regional police force, (2) a financial plan detailing the estimated costs 17 and projected savings resulting from the formation of the regional police 18 force, and (3) a plan for ensuring continued public safety during the 19 period of transition to a regional police force. The commissioner may 20 approve the application if the commissioner determines that the 21 regional police force would be sufficiently funded, managed and 22 effective and that the formation of such regional police force would 23 satisfy the requirements established by the provisions of this section.

(c) (1) Each regional police force shall establish a regional police
authority to oversee policy decisions, approve budgets, establish
operational priorities, manage police operations, allocate resources and
ensure that public safety standards are met. The regional police
authority shall consist of representatives from each member
municipality.

30 (2) Each regional police authority shall annually hold a public hearing
31 to review such regional police force's performance and consider
32 comments from residents of the member municipalities.

(3) Member municipalities that form a regional police force shall
jointly assume liability for actions taken by such regional police force.
Such member municipalities shall share the cost of liability insurance
proportionally on the basis of population.

37 (d) Each regional police authority shall annually submit a report to 38 the Commissioner of Emergency Services and Public Protection and the 39 chief elected official, chief executive officer and legislative body of each 40 of the member municipalities. Each such report shall include, but need 41 not be limited to, information regarding (1) the regional police force's 42 budget allocations and expenditures, (2) crime statistics and community 43 policing efforts in the member municipalities, and (3) the regional police 44 force's performance metrics, including, but not limited to, response 45 times, community outreach and officer staffing.

46 Sec. 2. (NEW) (Effective July 1, 2025) For the fiscal year ending June 30, 47 2026, and each fiscal year thereafter, the Commissioner of Emergency 48 Services and Public Protection shall administer a regional police force 49 incentive grant program to provide grants to member municipalities for 50 the costs associated with (1) establishing a regional police force, (2) 51 transitioning to a regional police force, (3) the ongoing operations of a 52 regional police force, (4) the construction of facilities, (5) law 53 enforcement equipment, and (6) crime prevention initiatives. The 54 commissioner shall develop (A) guidelines for the administration of 55 such grant program, and (B) eligibility criteria for participation and the 56 expenditure of grant funds. Member municipalities may apply on such 57 form and in such manner as prescribed by the commissioner. The 58 commissioner shall prioritize grant awards to member municipalities 59 with populations of less than thirty thousand, as determined by the 60 most recent decennial census.

This act shall take effect as follows and shall amend the following

Statement of Legislative Commissioners:

In Section 2, "develop guidelines for the administration of such grant program, eligibility criteria for participation and expenditure" was changed to "develop (A) guidelines for the administration of such grant program, and (B) eligibility criteria for participation and the expenditure" for clarity.

Explanation

The bill allows certain municipalities to form regional police forces, resulting in the following fiscal impacts.

Section 1 may result in a cost to municipalities with a population of 50,000 or less beginning in FY 26 that choose to form a regional police authority, to the extent that resources are used to establish the authority and apply to the Department of Emergency Services and Public Protection (DESPP).²

If DESPP receives enough applications to form regional police forces, they may need to hire one Associate Accountant and one State Police Lieutenant to review and make recommendations on such applications.

¹The fringe benefit costs for most state employees are budgeted centrally in accounts administered by the Comptroller. The estimated active employee fringe benefit cost associated with most personnel changes is 40.71% of payroll in FY 26.

² According to the Department of Public Health, in 2023 there were 150 municipalities with a population of 50,000 or less.

This results in a potential cost of \$240,000 in FY 26 and FY 27 to DESPP and \$110,364 to the State Comptroller - Fringe Benefits.³

Section 2, which requires DESPP to administer a grant program for various costs associated with establishing a regional police force, results in a potential significant cost to DESPP and a potential revenue gain to eligible municipalities beginning in FY 26 to the extent that DESPP allocates funding for this purpose.

It is estimated that grants for the costs associated with the transition to and ongoing operations of a regional police force, the construction of its facilities, and law enforcement equipment will cost tens of millions of dollars per regional police force. If DESPP receives enough grant applications, the agency may need to hire one Grants and Contracts Specialist. This results in a potential cost of \$90,000 in FY 26 and FY 27 to DESPP and \$36,639 to the State Comptroller - Fringe Benefits.

Municipalities with a population of 30,000 or less are prioritized for grant funding and are more likely to see a revenue gain.⁴

The Out Years

The annualized ongoing fiscal impact identified above would continue into the future subject to the number of regional police forces formed and inflation.

OLR Bill Analysis sSB 1489

AN ACT CONCERNING REGIONAL POLICE FORCES.

SUMMARY

This bill allows a regional police force to be formed on or after October 1, 2025, by two or more municipalities that each have a population of 50,000 or less. Interested municipalities must submit an application to the Department of Emergency Services and Public Protection (DESPP) commissioner for approval.

Each regional police force must establish a regional police authority to oversee certain items (e.g., approving budgets and setting operational priorities). The authority must also (1) include representatives from each member municipality and (2) annually report to DESPP and the chief elected officials of each member municipality on certain specified information (e.g., police performance metrics).

Finally, the bill requires DESPP to administer a regional police force incentive grant program to give grants to member municipalities for certain costs, including establishing and transitioning to a regional police force.

EFFECTIVE DATE: July 1, 2025

REGIONAL POLICE FORCE

Application Process

Under the bill, municipalities that want to form a force must submit an application to the DESPP commissioner, in the way he prescribes. The application must include:

1. a description of the regional police force's proposed structure and governance,

- 2. a financial plan detailing the estimated costs and projected savings from forming the regional police force, and
- 3. a plan for ensuring continued public safety during the transition period to a regional police force.

The DESPP commissioner may approve the application if he determines the regional police force would be sufficiently funded, managed, and effective and the formation would satisfy the bill's requirements.

Regional Police Authority

The bill requires each regional police force to establish a regional police authority to oversee policy decisions, approve budgets, set operational priorities, manage police operations, allocate resources, and ensure that public safety standards are met. The authority must (1) consist of representatives from each member municipality and (2) annually hold a public hearing to review the police force's performance and consider resident comments.

The bill requires member municipalities that form a regional police force to assume liability for the actions it takes. These municipalities must share the cost of liability insurance proportionally based on population.

The regional police authority must annually submit a report to the DESPP commissioner and the chief elected official, chief executive officer, and legislative body of each member municipality. The report must include information on:

- 1. the regional police force's budget allocations and expenditures;
- 2. crime statistics and community policing efforts in the member municipalities; and
- 3. the regional police force's performance metrics, including response times, community outreach, and officer staffing.

REGIONAL POLICE FORCE INCENTIVE GRANT PROGRAM

For FY 26 and annually after that, the bill requires DESPP to administer a regional police force incentive grant program that gives grants to member municipalities for the costs associated with:

- 1. establishing and transitioning to a regional police force,
- 2. operating a regional police force,
- 3. constructing facilities,
- 4. law enforcement equipment, and
- 5. crime prevention initiatives.

Under the bill, member municipalities may apply for these grants on a commissioner-prescribed form and in the way he determines. The commissioner must develop (1) guidelines for administering the grant program and (2) eligibility criteria for participation and the expenditure of grant funds. He must prioritize grant awards to member municipalities with populations of less than 30,000, as determined by the most recent decennial census.
