REASONS FOR BILL:

This bill establishes an interagency council on homelessness to work with the Commissioner of Housing to advise on improvements to the homelessness prevention and response efforts in Connecticut. The working group will be charged with: strengthening existing homelessness programs, improving the homelessness response system, and utilizing funding for housing assistance.

RESPONSE FROM ADMINISTRATION/AGENCY:

<u>Mairead Painter, State of Connecticut Long Term Care Ombudsman</u>: Mairead Painter is in support of this bill. The creation of this interagency council would align with the goal of the Long-Term Care Ombudsman Program to ensure the successful transition of individuals from long-term care facilities, "By coordinating efforts across agencies, the council can promote policies that prevent evictions, expand access to affordable housing, and improve support services for at-risk populations".

NATURE AND SOURCES OF SUPPORT:

<u>Sarah Fox, CEO, CT Coalition to End Homelessness</u> – Sarah Fox is in support of this bill and asked that it be amended, "to ensure that the bill aligns with national best practices, particularly when it comes to inclusive decision-making processes." The bill's current language does not clearly specify the inclusion of partners beyond state agencies, and the proposed amendments would, "ensure the broadest possible participation from impacted groups." Ms. Fox stated that this bill must include those with lived experience of

homelessness, those currently experiencing housing insecurity, and a wide range of partners. Ms. Fox also shared alternative models for organizing a state Interagency Council.

<u>Allen Alderfer, Rapid Rehousing Case Worker, New Reach Inc.</u> - Allen Alderfer is in support of this bill and asked that it be amended to "follow national best practices, ensuring participation in the decision-making process from people who are currently or formerly unhoused, service providers, partners, and advocates, alongside state agency leadership."

<u>Nadine Malone, CAN Manager, Journey Home</u> – Nadine Malone is in support of this bill and asked that it be amended to follow national best practices. They stated, "By formalizing the work of the Interagency Task Force into a Council, we can ensure that resources and efforts

across state agencies are better aligned and more effectively utilized." They explained that there are multiple state agencies currently involved in addressing homelessness, but the coordination between these agencies can be fragmented, so establishing an Interagency Council on Homelessness will being key stakeholders together, allowing the state to better "identify gaps in services, share resources, and avoid duplication of efforts."

<u>Matthew Morgan, Executive Director, Journey Home</u> – Matthew Morgan is in support of this bill and asked that it be amended to follow national best practices. They discussed funds from ARPA in 2024 that allowed them to assist, "21 partner agencies to support 228 unique households to overcome assorted barriers to stable housing with these funds which cost a total of \$464,551." They stated that the funds were temporary and needed to be annualized to inflation to continue serving households.
