SPONSORS OF BILL:

The Public Health Committee.

REASONS FOR BILL:

The bill allows marital and family therapists licensed or certified in other states to be granted a license by the Connecticut Department of Public Health (DPH) if the other state's licensure standards are equivalent to, or higher than Connecticut's. Applicants who are from states not considered equivalent to Connecticut's licensure standards may substitute three years of work experience for the supervised practicum and postgraduate experience.

The substitute language provides licensure portability for fully licensed marriage and family therapists versus those in probationary periods.

RESPONSE FROM ADMINISTRATION/AGENCY:

NATURE AND SOURCES OF SUPPORT:

Jaime Rodriguez, Advocacy Chair, CT Association of MFT:

She stated that marriage and family therapists (MFT) practice in numerous settings and accept various insurance plans from private to Medicaid. She commented that MFTs are on the frontline of the mental health crisis and are trained through a systemic lens. She pointed out that MFT's are a smaller number of the specialized mental health provider community and that they do not have the number of professionals to engage in a compact. She stated that based on her organization's research, Connecticut is at or below other state's standards. She would like to exclude the associate level from portability as the intent was that portability

would only apply to fully licensed MFTs. She mentioned that other states have passed licensure portability for MFTs and believes that Connecticut should join those states.

Roger Smith, Chief Advocacy Officer, AAMFT:

He stated that approximately 1.54 million Connecticut residents are living in a designated mental health workforce shortage area and that the bill is based on nationally recognized licensure standards for MFTs. He mentioned that Virginia, Maryland, Arizona, and Tennessee have implemented similar programs that allow an MFT who has graduated from an accredited master's program, completed at least two years of supervised clinical experience, and passed the national licensure exam to practice in other states. He commented that qualified MFTs often face burdensome obstacles when relocating to Connecticut because of current licensure requirements. He believes that the bill ultimately will align Connecticut with best practices from other states, streamlining regulatory processes, and eliminating redundant licensing barriers.

Rebecca Burton, Practice Owner, Beehive Counseling:

She stated that this bill will increase access to care as currently their office alone fields dozens of calls each week from frustrated would-be couples and families. She spoke to another provider who was looking for family therapy and had called 53 providers with no luck.

Paul Levantino, Chairperson and Professor, SCSU MFT Department:

He believes that as chairperson of one of the three MFT programs in the state, this bill will provide Connecticut with a well-trained pool of mental health clinicians.
