REASONS FOR BILL:

Currently, hunting in the state is banned on Sundays in locations where it is otherwise permitted during the rest of the week. Allowing hunting on Sundays would provide another day for hunters to practice their activities.

Substitute Language LCO 6923

The substitute language replaced the underlying bill, which would have allowed Sunday hunting generally, as on any other day of the week.

RESPONSE FROM ADMINISTRATION/AGENCY:

Katie S. Dykes, Commissioner, CT Department of Energy & Environmental Protection

DEEP supports HB 7231 allowing hunting on Sundays in the same state forests and wildlife management areas that hunting is allowed in now. During hunting season, hunters and non-hunters have safely enjoyed outdoor recreation on public lands in Connecticut. There has been a 27% decline in hunting and "available time" is cited as the most limiting factor. There are strict regulated harvest limits, so Sunday hunting is not expected to adversely impact the sustainability of the wildlife population.

NATURE AND SOURCES OF SUPPORT:

Robert LaFrance, Director of Policy for Connecticut, National Audubon Society

The Audubon Society supports HB 7231 if it doesn't expand into the Sundays during the CBC season which is when thousands participate in helping conduct the collection of data to detect and better understand changes in bird species habitat ranges and population size.

Cyrus Hunter Baird, Senior Director of Government Affairs, Delta Waterfowl Foundation

The Delta Waterfowl Foundation supports HB 7231. The sportsmen and women help pay for most of the conservation funding in Connecticut. The funds are from purchasing hunting licenses, permits tags and migratory waterfowl stamps. DEEP depends on these funds for species conservation. Hunters continue to be one of the only user group activities discriminated against on Sunday. Lack of time is the number reason that hunters stop hunting. People opposing this legislation argue that non-hunters need one day from hunters on Sundays due to perceived safety concerns of hunters and non-hunters occupying the same outdoor areas even though those arguments are not supported by any data.

NATURE AND SOURCES OF OPPOSITION:

Samantha Dynowski, State Director, Sierra Club Connecticut

The Sierra Club opposes allowing Sunday hunting in Connecticut. They feel it is very important to keep one day a week when people can hike, picnic, birding or simply appreciate the outdoors without worrying about whether someone is hunting nearby. Hunting 6 out of 7 days should cover the rights of hunters.

Alan J. Siniscalchi, President, CT Association of Conservation and Inland Wetlands Commission

CT Association of Conservation and Inland Wetland Commission opposes HB 7231 not because of hunting but that their member conservation commissioners have valued the ability to enter wooded lands, wetland, and other space habitats to conduct scientific studies on Sundays. On Sundays, they can conduct wildlife surveillance free from the noise of firearm discharges which will scatter birds and other animals and adversely affect surveillance counts.
