REASONS FOR BILL:

HB-7252 requires the Court Support Services Division of the Judicial Branch to report on community support services for disconnected and justice-involved youth. Reforming Connecticut's juvenile justice system includes expanding community services that prioritize rehabilitation and community-based interventions, as these are evidence-based initiatives that reduce recidivism and help juveniles successfully reintegrate into their communities. This reporting will aid understanding of these initiatives by gathering the appropriate data.

DOMUS supports HB-7252 because providing justice-involved and disconnected youth with school engagement and workforce development "empower[s] them to pursue their path to self-sufficiency." Catalyst CT focuses on diversion from the justice system and school-based conflict resolution. Evidence-based restorative practices help juveniles prioritize relationships and disentangle from the root causes of violence, keeping youth engaged in education and fostering resilience.

Mr. Donald strongly recommends "the reporting requirements include programs like youth mediation and credible messenger initiatives that are currently operating without direct state funding."
