## SPONSORS OF BILL:

#### **REASONS FOR BILL:**

The youth voters are a demographic that has had historically low voter-turnout rates in elections. This bill would allow individuals to pre-register to vote once they have turned 16 instead of waiting until their 18<sup>th</sup> birthday for registration. This bill would seek to increase civic participation among youth voters and keep them civically engaged.

# **RESPONSE FROM ADMINISTRATION/AGENCY:**

#### Stephanie Thomas, Secretary of State:

This allows future voters to take hold of their stake in democracy. Twenty states already allow sixteen-year-olds to pre-register to vote and it has increased their voter turnouts significantly. This increased turnout comes from a variety of voting subgroups and notably is equally effective for Democratic and Republican registrants. Connecticut's newly established centralized voter registration system will enable this program to be easily implemented.

# NATURE AND SOURCES OF SUPPORT:

#### Cylie Kirejczyk, Intern at the Connecticut Secretary of State office:

This empowers 16-year-olds, allowing them to register to vote before the responsibilities of adulthood can prevent them from doing so. Early involvement also makes people feel more relevant to the democratic process and encourages continued involvement. We already trust 16-year-olds to work, pay taxes, and drive – we should trust them to prepare to vote.

#### Jess Zaccagnino, Policy Counsel for ACLU-CT:

This works towards the goal of maximizing voter turnout. It has been shown that engaging future voters at a young age increases voter registration in both the short and long term.
