#### **REASONS FOR BILL:**

Accidental boat transport of AIS is one of the leading causes of AIS transfer between water bodies. Gardner Lake would like DEEP to establish a pilot program for a boat washing station to reduce the spread of aquatic invasive species.

#### **RESPONSE FROM ADMINISTRATION/AGENCY:**

#### Katie S. Dykes, Commissioner, CT Department of Energy & Environmental Protection

DEEP is in support of the intent of the bill acknowledging that boat washing stations help reduce the spread of aquatic invasive species which clog up our lakes. Their concern is regarding the fiscal impact since Gardner Lake currently doesn't have water or power utilities.

#### Sen. Martha Marx, 20th District.

Sen. Marx cosponsored this legislation to have DEEP establish a pilot program for a washing station at Gardner Lake in Salem to remove aquatic invasive species from their boats and to learn the proper method for the removal of plant material from the prop, hull, and motor of a boat. This will help in stopping the spread of aquatic invasive species and make the lake more recreational friendly.
