REASONS FOR BILL:

To prohibit the sale of certain lighter-then-air balloons to protect marine life and protect the environment from litter.

SUBSTITUTE LANGUAGE LCO 5454

DEEP shall engage representatives of the helium industry, to develop a schedule for the phase out of helium utilized to fill lighter-than-air balloons not later than October 1, 2025, and to end such use in the state by December 31, 2027. The Commissioner shall submit a report to the joint standing committee relating to this matter no later then February 1, 2026.

RESPONSE FROM ADMINISTRATION/AGENCY:

Katie S. Sykes, Commissioner, Connecticut Department of Energy and Environmental Protection

DEEP appreciates the intent of SB 1154 but they have concerns with this bill:

1. Biodegradable balloons can persist in the environment for years before fully degrading. The term "biodegradable" may create a misleading public perception that such balloons are safe for the environment and wildlife. We need to clarify the definition of "biodegradable" for this bill.

- 2. Tethered, non-biodegradable, lighter-than-air balloons can be tools for non-lethal wildlife deterrence and weather-related research. Therefore, the bill should exempt these categories from the prohibition.
- 3. While the bill does not make enforcement by DEEP mandatory, they also note that DEEP currently lacks the authority or expertise to enforce prohibitions on the sale of balloons, having only jurisdiction only to prevent their release.

NATURE AND SOURCES OF SUPPORT:

Rep. Irene Haines, 34th District

Rep Haines Supports SB 1154. Even though Connecticut's current laws prohibit the intentional release of ten or more helium or other lighter than air ballons, Rep. Haines feels that SB 1154 will further protect wildlife from the release of any balloons into the air because they are still trash and a hazard unless instantaneously biodegradable.
