REASONS FOR BILL:

This bill would seek designate a legal holiday as known as Indigenous Peoples Day. There is a growing sentiment in the Country and State to honor the contributions indigenous people have made to our culture and society. This would also help highlight the discrimination and issues indigenous people still face today.

Cathy Osten, Senator, 19th Senate District:

A dozen states have already established and Indigenous Peoples Day to recognize the contributions made to our society by Native Americans. The day would help being attention to the discrimination of Native Americans and their lands. There is a day know as Native American Heritage Day which is the Friday after thanksgiving.

Jody Cummings, General Council, Mashantucket Pequot Tribe:

We applaud this movement to honor and recognize the diverse cultures and histories of Indigenous people as well as their contributions. Adding this day promotes a more inclusive understanding of history and recognizes the resilience, wisdom, beauty and contributions of Indigenous communities. It also will promote cultural understanding.

Mohegan Tribal Leadership:

Indigenous people have made significant contributions to our state and designating this as legal holiday is a powerful gesture of recognition and respect. All citizens will have the opportunity to honor indigenous people and celebrate their heritage and learn from their experiences.

Chief Richard Velky, Schaghticoke Tribal Nation:

As one of Connecticut's first people we than Mother Earth and are blessed by the Creator for all that has been bestowed upon us. In 1988 Governor, William A. O'Neill proclaimed "Indian Day" as September 30th, 1988. He officially recognized the Connecticut tribes and their knowledge, customs, and ideals as an important part of our heritage.
