# **REASONS FOR BILL:**

The reason for this bill is to provide \$500,000 in both FY 26 and FY 27 of additional funding to educate and train domestic workers.

# NATURE AND SOURCES OF SUPPORT:

Tatiana Bejar, Director of Local Organizing Programs at the National Domestic Workers Alliance and coordinator of the Connecticut Domestic Workers Justice Coalition: Supports the bill. States that funding the program is essential to ensuring that all domestic workers in the state know their rights under the law and how to report labor rights abuses. Adding that robust outreach efforts by community organizations that are already trusted is the best way to improve the working conditions of domestic workers. States the success of this program and similar ones in other states shows that it should be expanded in CT. Adding that through this partnership, organizations have provided on-the-ground outreach and education, assisting domestic workers in accessing their new rights, employers complying with their new responsibilities, and supporting workers whose rights have been violated to access remedies.

Nelli Jara, Executive Director of Connecticut Worker Center and Connecticut Domestic Workers Justice Coalition: Supports the bill. States that passing the bill will ensure that

domestic workers' rights are fully realized, and that employers have the information needed to comply with the law. Adding that through the partnership organizations have provided much needed education about legal rights and legal access to domestic workers. Urges the passage of the bill to continue and strengthen the collaboration with the CTDOL in outreach and education, support investigation of rights abuses, create referrals to legal services and broaden enforcement of Paid Sick Leave. Adding they need the state to support Domestic workers just they support their family.

Rodrigo Nino, Community Organizer and member of organization Comunidades Sin Fronteras: Supports the bill. States that passing the bill will ensure the rights of domestic workers in Connecticut. Adding that even with new laws, many workers still do not know their rights or how to enforce them. Through this partnership, the organizations have carried out outreach activities on the ground, helping domestic workers understand their new rights and employers understand their new responsibilities, as well as supporting workers whose rights have been violated to access other remedies.

**Elza Monteiro, Portuguese Worker Leader at Connecticut Worker Center:** Supports the bill. States that Know your rights education in the Portuguese speaking community is important and that they are astounded when they do outreach at how many people don't know what the minimum wage is. Adding that most domestic workers are paid a lot less than the \$16.35 minimum. This lack of knowledge helps employers to keep modern slavery going, also helps employers putting fear into the employees. Add they need the funding to continue the KNOW YOUR RIGHTS education.

**Zenia Castillo, domestic worker, member Comunidades Sin Fronteras CT:** Supports the bill. States they benefited from education from the program, where they learned their rights, but there are still many workers who do not know their rights or how to enforce them. Urges the passage of the bill to continue and strengthen the collaboration with the CTDOL in outreach and education, support investigation of rights abuses, create referrals to legal services and broaden enforcement of Paid Sick Leave. Adding they need the state to support Domestic workers just they support their family.

**Carmen Lanche, Director of the Comunidades Sin Fronteras CT:** Supports the bill. States the union represents thousands of domestic workers and employers across CT. Adding that expanding educational activities has decreased the overall number of wage theft violations, and they want more people informed of their rights to protect themselves from exploitation. Urges support so they can continue to support families across the state.

Urges passage of bill, saying These employees are mostly women, mostly immigrants of color, who provide services in the homes of those who can afford to hire them. They clean houses, or provide care and support

for children, elderly relatives, or people with disabilities. States that as some of society's least empowered people, they are often victims of wage theft, they are forced to work overtime without pay or if they aren't given Paid Sick Leave when they're eligible for it, they often don't have any recourse. States the bill will help get the word out that domestic workers are subject to the wage and hour laws, and help hire enough employees to enforce the law, this bill will help ensure that domestic workers' rights in CT are fully realized, and that employers have all the information they need to comply with the law. Adding that if we want equity, we must provide funding for worker protections.

**Jossette Stewart, domestic worker Connecticut Worker:** Supports the bill. States they have worked as a home care worker that didn't receive wages or overtime from working long shifts. States the DOL has helped but the case wasn't resolved and has a lawyer trying to help get back wages. Urges to support for the bill stating it will ensure that domestic workers' rights in CT are fully realized, and that employers have the information they need to comply with the law.

Karime Pimentel, Naugatuck Valley Project, affiliates of the National Domestic Workers Alliance for the State of CT: Supports the bill. States they are a non-profit community organization that since 1983 has been developing rights advocacy work for the community and has carried out educational work not only for domestic workers, but also the employers of domestic workers, so both sides are aware of the law. States the history of funding for their work and that they need a more stable solution to continue their work to educate and expand outreach in our communities.

**Dr Linda Dalessio:** Supports the bill on the condition that the bill should be amended so funds are only used for American Citizens.
