## AN ACT REQUIRING THE REPORTING OF THE STATUS OF THE IMPLEMENTATION OF RECOMMENDATIONS OF THE CREATES PROJECT REPORT CONCERNING DIGITIZATION.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (Effective from passage) Not later than February 1, 2026, the 2 Secretary of the Office of Policy and Management shall report to the joint 3 standing committee of the General Assembly having cognizance of 4 matters relating to government oversight, in accordance with the 5 provisions of section 11-4a of the general statutes, on the status of 6 digitization efforts by state agencies to implement the CREATES project 7 report recommendations. Such report shall include, but need not be 8 limited to, the status of hiring staff, as necessary to implement such 9 recommendations, the capital funding, the implementation and any 10 realized savings for the following programs as of December 31, 2025:

(1) The Department of Revenue Services, concerning the data-driventax compliance program;

(2) The Office of Policy and Management, concerning the state-widegrants program and portal;

15 (3) The Commission on Human Rights and Opportunities,16 concerning streamlining affirmative action reporting;

17 (4) The office of the Treasurer, Department of Administrative
18 Services and Office of Policy and Management, concerning creating a
19 common payment platform;

20 (5) The Department of Administrative Services, concerning creating21 a state-wide digital service center;

(6) The Department of Mental Health and Addiction Services,concerning implementing an electronic health record system; and

24 (7) The Labor Department, on the unemployment insurance25 modernization upgrades.

26 Sec. 2. (NEW) (Effective from passage) Not later than February 1, 2026, 27 and annually thereafter, the Secretary of the Office of Policy and 28 Management shall submit a report, in accordance with the provisions of 29 section 11-4a of the general statutes, to the joint standing committee of 30 the General Assembly having cognizance of matters relating to 31 government oversight. Such report shall include, but need not be 32 limited to, a summary of the overtime granted by each agency and the 33 management tools utilized by each agency to attempt to curtail such 34 overtime.
