AN ACT CONCERNING FUNDING FOR SCHOOL MEALS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 That the sum of _____ dollars be appropriated to the Department of
- 2 Education, from the General Fund, for the fiscal year ending June 30,
- 3 2026, to provide (1) breakfasts to students at no cost at schools
- 4 participating in the school breakfast program, and (2) lunch to students,
- 5 who are eligible for reduced-price meals, at no cost at schools
- 6 participating in the school lunch program.

Statement of Purpose:

To provide funding to reimburse school districts for the difference between the federal reimbursement rate for reduced-price and fully paid school meals.
