AN ACT REQUIRING A STUDY OF COMMUNICATION SYSTEMS USED BY PUBLIC SAFETY PERSONNEL AND ESTABLISHING A WORKING GROUP TO STUDY THE CONSOLIDATION OF PUBLIC SAFETY ANSWERING POINTS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (Effective from passage) (a) The Division of State-Wide
- 2 Emergency Telecommunications within the Department of Emergency
- 3 Services and Public Protection shall study the policies and practices
- 4 related to the use of communication systems among public safety
- 5 personnel, identify any concerns regarding the sharing of private
- 6 information, such as health information, through such systems and
- 7 recommend appropriate changes to such policies and practices
- 8 regarding the sharing of such information. In conducting such study,
- 9 the division shall consult with the Emergency Medical Services
- 10 Advisory Board, established pursuant to section 19a-178a of the general
- 11 statutes, the Commission on Fire Prevention and Control, established
- 12 pursuant to section 7-323k of the general statutes, and the Police Officer
- 13 Standards and Training Council, established pursuant to section 7-294b
- 14 of the general statutes.

(b) Not later than January 1, 2026, the division shall submit a report, in accordance with the provisions of section 11-4a of the general statutes, to the joint standing committee of the General Assembly having cognizance of matters relating to public safety and security. Such report shall include the results of the study conducted pursuant to subsection (a) of this section and any recommendations for changes to statutes, policies and practices related to the use of communication systems among public safety personnel.

Sec. 2. (*Effective from passage*) (a) There is established a working group to study the current system of public safety answering points and make recommendations for consolidating such answering points while prioritizing the need to ensure public safety. The working group shall consider and make recommendations regarding: (1) The establishment of state goals regarding consolidation, (2) the definition of "regional public safety answering point", (3) any challenges to consolidation presented by existing collective bargaining agreements, (4) issues that may arise in municipalities that would no longer have an individual physically located within the municipality to act as a dispatcher at all times after consolidation, (5) time frames for consolidation, (6) where and how to locate regional public safety answering points, (7) ways to enhance the skills of telecommunicators, as defined in section 28-30 of the general statutes, and personnel providing emergency medical dispatch, as defined in section 28-25 of the general statutes, including recommendations regarding training standards and performance accountability, (8) the governance structure for regional public safety answering points, and (9) any other related issues the working group deems appropriate.

- (b) The working group shall consist of the following members:
- 43 (1) A representative of an organization of municipal leaders that 44 represents the towns of the state;
- 45 (2) A representative of a labor organization representing employees 46 of public safety answering points;

- 47 (3) A representative of an association of police chiefs;
- 48 (4) A representative of an association of professional firefighters;
- 49 (5) A member of the joint standing committee of the General
- 50 Assembly having cognizance of matters relating to public safety and
- 51 security;
- 52 (6) A current or former director of a regional public safety answering
- 53 point;
- 54 (7) A representative of an association of managers of emergency
- 55 communication centers;
- 56 (8) A representative of the Emergency Medical Services Advisory
- 57 Board established under section 19a-178a of the general statutes;
- 58 (9) A representative of an association of fire chiefs;
- 59 (10) A representative of an organization that advocates for the
- 60 interests of small towns in the state;
- 61 (11) A representative of an association of councils of government;
- 62 (12) A member of the joint standing committee of the General
- 63 Assembly having cognizance of matters relating to planning and
- 64 development;
- 65 (13) The commanding officer of the Division of State Police within the
- 66 Department of Emergency Services and Public Protection, or the
- 67 commanding officer's designee;
- 68 (14) The director of the Division of State-Wide Emergency
- 69 Telecommunications within the Department of Emergency Services and
- 70 Public Protection, or the director's designee; and
- 71 (15) The undersecretary of the Intergovernmental Policy and
- 72 Planning Division within the Office of Policy and Management, or the
- 73 undersecretary's designee.

(c) The Commissioner of Emergency Services and Public Protection shall appoint the members described in subdivisions (1) to (12), inclusive, of subsection (b) of this section.

- (d) Any member of the working group appointed under subdivisions
 (1) to (12), inclusive, of subsection (b) of this section may be a member
 of the General Assembly.
 - (e) All initial appointments to the working group shall be made not later than thirty days after the effective date of this section. Any vacancy shall be filled by the appointing authority.
 - (f) The Commissioner of Emergency Services and Public Protection shall select the chairpersons of the working group from among the members of the working group. Such chairpersons shall schedule the first meeting of the working group, which shall be held not later than sixty days after the effective date of this section. Such chairpersons may establish subcommittees of the members as needed and designate a chairperson of each such subcommittee.
 - (g) The administrative staff of the joint standing committee of the General Assembly having cognizance of matters relating to public safety and security shall serve as administrative staff of the working group.
 - (h) The working group shall submit, in accordance with the provisions of section 11-4a of the general statutes, to the joint standing committees of the General Assembly having cognizance of matters relating to public safety and security and planning and development: (1) An interim report on the findings and recommendations of the working group not later than February 1, 2026, and (2) a final report on the findings and recommendations of the working group not later than January 1, 2027. The working group shall terminate on the date that it submits such final report or January 1, 2027, whichever is later.
