AN ACT EXCLUDING EXCUSED ABSENCES FOR STUDENT OBSERVANCE OF RELIGIOUS HOLIDAYS FROM TRUANCY DETERMINATIONS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Section 10-198a of the general statutes is repealed and the
 following is substituted in lieu thereof (*Effective July 1, 2025*):

(a) For purposes of this section and sections 10-198c and 10-220,
"truant" means a child age five to eighteen, inclusive, who is enrolled in
a public or private school and has four unexcused absences from school
in any one month or ten unexcused absences from school in any school
year.

8 (b) Each local and regional board of education shall adopt and 9 implement policies and procedures concerning truants who are enrolled 10 in schools under the jurisdiction of such board of education. Such 11 policies and procedures shall include, but need not be limited to, the 12 following: (1) The holding of a meeting with the parent of each child 13 who is a truant, or other person having control of such child, and 14 appropriate school personnel to review and evaluate the reasons for the 15 child being a truant, provided such meeting shall be held not later than 16 ten school days after the child's fourth unexcused absence in a month or 17 tenth unexcused absence in a school year, (2) coordinating services with 18 and referrals of children to community agencies providing child and 19 family services, (3) annually at the beginning of the school year and 20 upon any enrollment during the school year, notifying the parent or 21 other person having control of each child enrolled in a grade from 22 kindergarten to eight, inclusive, in the public schools in writing of the 23 obligations of the parent or such other person pursuant to section 10-24 184, (4) annually at the beginning of the school year and upon any 25 enrollment during the school year, obtaining from the parent or other 26 person having control of each child in a grade from kindergarten to 27 eight, inclusive, a telephone number or other means of contacting such 28 parent or such other person during the school day, (5) (A) on or before 29 August 15, 2018, the implementation of a truancy intervention model 30 identified by the Department of Education pursuant to subsection (a) of 31 section 10-198e for any school under its jurisdiction that has a 32 disproportionately high rate of truancy, as determined by the 33 Commissioner of Education, and (B) on or before September 1, 2023, the 34 adoption and implementation of a truancy intervention model 35 developed by the Department of Education pursuant to subsection (b) 36 of section 10-198e that accounts for mental and behavioral health, or a 37 similar truancy intervention plan that meets all of the requirements for 38 a truancy intervention model set forth in subsection (b) of said section, 39 (6) a system of monitoring individual unexcused absences of children in 40 grades kindergarten to eight, inclusive, which shall provide that 41 whenever a child enrolled in school in any such grade fails to report to 42 school on a regularly scheduled school day and no indication has been 43 received by school personnel that the child's parent or other person 44 having control of the child is aware of the pupil's absence, a reasonable 45 effort to notify, by telephone and by mail, the parent or such other 46 person shall be made by school personnel or volunteers under the 47 direction of school personnel, (7) providing notice to the parent or 48 guardian of a child who is a truant of the information concerning the

49 existence and availability of the 2-1-1 Infoline program, and other 50 pediatric mental and behavioral health screening services and tools 51 described in section 17a-22rt, and (8) on and after July 1, 2023, a 52 requirement that an appropriate school mental health specialist, as 53 defined in section 12 of public act 22-47, conduct an evaluation of each 54 child who is a truant to determine if additional behavioral health 55 interventions are necessary for the well-being of the child. Any person 56 who, in good faith, gives or fails to give notice pursuant to subdivision 57 (6) of this subsection shall be immune from any liability, civil or 58 criminal, which might otherwise be incurred or imposed and shall have 59 the same immunity with respect to any judicial proceeding which 60 results from such notice or failure to give such notice.

61 (c) Nothing in subsections (a) and (b) of this section shall preclude a 62 local or regional board of education from adopting policies and 63 procedures pursuant to this section which exceed the requirements of 64 said subsections.

65 (d) The provisions of this section shall not apply to any child 66 receiving equivalent instruction pursuant to section 10-184.

67 (e) A child, age five to eighteen, inclusive, who is enrolled in a public 68 or private school and whose parent or legal guardian is an active duty 69 member of the armed forces, as defined in section 27-103, and has been 70 called to duty for, is on leave from or has immediately returned from 71 deployment to a combat zone or combat support posting, shall be 72 granted ten days of excused absences in any school year and, at the 73 discretion of the local or regional board of education, additional excused 74 absences to visit such child's parent or legal guardian with respect to 75 such leave or deployment of the parent or legal guardian. In the case of 76 excused absences pursuant to this subsection, such child and parent or 77 legal guardian shall be responsible for obtaining assignments from the 78 student's teacher prior to any period of excused absence, and for 79 ensuring that such assignments are completed by such child prior to [his 80 or her] such child's return to school from such period of excused

81 absence.

82	(f) A child, age five to eighteen, inclusive, who is enrolled in a public
83	or private school shall be granted one day as an excused absence in any
84	school year and, at the discretion of the local or regional board of
85	education, additional excused absences to observe a religious holiday.
86	In the case of an excused absence pursuant to this subsection, such child
87	and parent or legal guardian shall be responsible for obtaining
88	assignments from the student's teacher prior to such excused absence,
89	and for ensuring that such assignments are completed by such child
90	upon such child's return to school from such excused absence.

This act shall take effect as follows and shall amend the following sections:

Statement of Purpose:

To exclude excused absences for student observance of religious holidays from truancy determinations.
