**AN ACT REQUIRING ANNUAL PERFORMANCE AUDITS OF
MEDICAID-FUNDED PROGRAMS BY THE AUDITORS OF PUBLIC
ACCOUNTS.**

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. (NEW) (*Effective July 1, 2025*) Not later than December 1,
2 2025, and annually thereafter, the Senate chairperson and the House
3 chairperson of the joint standing committee of the General Assembly
4 having cognizance of matters relating to human services shall provide
5 to the Auditors of Public Accounts a written list of not less than two
6 Medicaid-funded programs to be subject to performance audits by said
7 auditors in accordance with section 2-90 of the general statutes, as
8 amended by this act. Not later than thirty days after the completion of
9 the performance audits, the Commissioner of Social Services shall post
10 a link to the audit results and recommendations on the Internet web site
11 of the Department of Social Services.

12 Sec. 2. Section 2-90 of the general statutes is amended by adding
13 subsection (j) as follows (*Effective January 1, 2026*):

14 (NEW) (j) Notwithstanding the provisions of subsection (c) of this
15 section, said auditors shall conduct not less than two performance

16 audits annually of Medicaid-funded programs from a list of such
17 programs provided to the auditors, in writing, by the Senate
18 chairperson and the House chairperson of the joint standing committee
19 of the General Assembly having cognizance of matters relating to
20 human services, in accordance with section 1 of this act. Any such
21 program being audited by the auditors shall provide any information
22 the auditors deem necessary to conduct such audit. The auditors shall
23 report their findings and recommendations, in accordance with the
24 provisions of section 11-4a, to the Governor, the State Comptroller and
25 the joint standing committees of the General Assembly having
26 cognizance of matters relating to appropriations and the budgets of state
27 agencies and human services.

This act shall take effect as follows and shall amend the following sections:

To ensure optimum use of Medicaid dollars toward providing human services through utilization of performance audits conducted by the Auditors of Public Accounts.
