AN ACT CONCERNING RACIAL AND ETHNIC IMPACT STATEMENTS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Section 2-24b of the general statutes is repealed and the 2 following is substituted in lieu thereof (*Effective October 1, 2025*):

3 (a) Beginning with the session of the General Assembly commencing 4 on January [9, 2019] 6, 2027, a racial and ethnic impact statement shall 5 be prepared with respect to certain bills [and amendments] at the 6 request of any member of the General Assembly. With respect to a bill 7 favorably reported during the regular session, any such request shall be 8 made not later than [ten] two days after the deadline for the committee 9 that introduced the bill to vote to report favorably under the joint rules 10 of the House of Representatives and the Senate. [With respect to an 11 amendment introduced during the regular session, any such request 12 shall be made at least ten days prior to the deadline for adjournment 13 sine die of the regular session.]

(b) The [joint standing committee of the General Assembly havingcognizance of matters relating to government administration may make

16 recommendations for a provision to be included in the joint rules of the 17 House of Representatives and the Senate concerning the procedure for 18 the preparation of such racial and ethnic impact statements, the content 19 of such statements and the types of bills and amendments with respect 20 to which such statements should be prepared] Commission on Racial 21 Equity in Public Health, established pursuant to section 19a-133a, shall 22 develop procedures for a member to request and the commission to 23 prepare a racial and ethnic impact statement. The commission shall 24 memorialize such procedures in a letter to the speaker of the House of 25 Representatives, president pro tempore of the Senate, majority leader of 26 the Senate, minority leader of the Senate, majority leader of the House 27 of Representatives and minority leader of the House of Representatives 28 with a request for such procedures to be included in the joint rules of 29 the House of Representatives and the Senate.

30 (c) (1) Notwithstanding any provision of the general statutes 31 concerning the confidentiality of records and information, the 32 commission may request of any public agency, as defined in section 1-33 200, or quasi-public agency, as defined in section 1-120, records and 34 information for purposes of preparing a racial and ethnic impact 35 statement pursuant to this section.

36 (2) Any public agency or quasi-public agency receiving a request for
37 records or information pursuant to subdivision (1) of this subsection,
38 shall submit, not later than five days after the date of such request and
39 in the manner requested by the commission, such records or
40 information.

(3) If a public agency or quasi-public agency needs additional time to comply with such request, the public agency or quasi-public agency shall specify the reason for such need to the commission not later than two days after the date of the request for records or information. The commission shall provide such public agency or quasi-public agency a reasonable extension of time to fulfill such request.
