Strike everything after the enacting clause and substitute the
following in lieu thereof:

3 "Section 1. (*Effective from passage*) (a) There is established an account 4 to be known as the "emergency nonprofit assistance account", which 5 shall be a separate nonlapsing account. The amount of three million 6 dollars shall be transferred to the account from the General Fund, 7 provided the cumulative monthly statements of revenue and 8 expenditures prepared by the Secretary of the Office of Policy and 9 Management on or about April 20, 2025, pursuant to subdivision (4) of 10 section 4-66 of the general statutes project a surplus of at least said 11 amount for the fiscal year ending June 30, 2025. The account shall also 12 contain all other moneys required or permitted by law to be deposited 13 in the account.

14 (b) Moneys in the account shall be expended by the Chief Court
