Title: AN ACT CONCERNING THE ESTABLISHMENT OF THE CONNECTICUT STATE SEAL OF CIVICS EDUCATION AND ENGAGEMENT, THE TRANSPARENCY OF MULTILINGUAL LEARNER DATA, THE USE OF SMART DEVICES IN SCHOOLS, THE AVAILABILITY OF ISLAMIC AND ARAB STUDIES CURRICULUM MATERIAL FOR SCHOOL DISTRICTS, THE ESTABLISHMENT OF A WORKING GROUP TO ADDRESS ANTISEMITISM IN SCHOOLS, EDUCATION MANDATE RELIEF AND VARIOUS AND ASSORTED REVISIONS TO THE EDUCATION STATUTES.

Statement of Purpose: To require the State Board of Education to establish a Connecticut State Seal of Civics Education and Engagement to affix on the high school diploma of any student demonstrating a high level of proficiency in such subject matter.
