Title: AN ACT IMPLEMENTING THE RECOMMENDATIONS OF THE DEPARTMENT OF MOTOR VEHICLES AND CONCERNING PENALTIES FOR OPERATING A MOTOR VEHICLE AND VESSEL WHILE UNDER THE INFLUENCE OF INTOXICATING LIQUOR OR ANY DRUG, TECHNICAL CORRECTIONS TO THE MOTOR VEHICLE STATUTES, VIDEO PRESENTATION UPON LICENSE RENEWAL, THE HIGHWAY WORK ZONE AND ROADSIDE VEHICLE SAFETY AWARENESS PROGRAM, YELLOW AND BLUE ENVELOPES, ELECTRIC SCOOTERS, ELECTRIC BICYCLES, MOTOR-DRIVEN CYCLES, INSTALLMENT PAYMENT PLANS, LOW-SPEED VEHICLE DEALERS AND FINES FOR VIOLATIONS OF "MOVE OVER" LAW AND AGGRAVATED ENDANGERMENT OF A HIGHWAY WORKER.

Statement of Purpose: To (1) implement the recommendations of the Department of Motor Vehicles, (2) revise the penalties for operating a motor vehicle and vessel while under the influence of intoxicating liquor or any drug, (3) require notice of casual car sales to the department, (4) charge a registration fee for a pontoon boat based on its overall length, and (5) make technical revisions to the motor vehicle statutes.
