Title: AN ACT CONCERNING STATE CONTRACTS WITH NONPROFIT HUMAN SERVICES PROVIDERS.

Statement of Purpose: To (1) require the Secretary of the Office of Policy and Management to conduct reviews of the level of services and reporting requirements of nonprofit human services providers, and (2) repeal provisions concerning the cost allowance cap for executive director salaries in certain state agencies' calculations of grants to nonstate organizations that provide employment opportunities, day services, or residential facility services.
