Title: AN ACT CONCERNING THE ILLEGAL USE OF CERTAIN VEHICLES AND STREET TAKEOVERS.

Statement of Purpose: To (1) revise provisions regarding forfeiture of certain illegally used vehicles, (2) authorize municipalities to adopt an ordinance related to street takeovers, and (3) revise the time period for suspension of an operator's license and to allow for revocation of a license due to violations related to a street takeover.
