**Title:** AN ACT ASSESSING A CERTAIN FEE FOR DEPOSIT INTO THE FIREFIGHTERS CANCER RELIEF ACCOUNT.

**Statement of Purpose:** To provide that telephone and telecommunications companies providing local telephone service, providers of commercial mobile radio service and providers of voice over Internet protocol service shall assess against each subscriber a fee in an amount equal to five cents per month per access line for deposit into the firefighters cancer relief account.
