Substitute Senate Bill No. 1563

Senate, May 28, 2025

The Committee on Government Oversight reported through SEN. GADKAR-WILCOX of the 22nd Dist., Chairperson of the Committee on the part of the Senate, that the substitute bill ought to pass.

AN ACT CONVEYING PARCELS OF STATE LAND KNOWN AS CAMP BROOK GREENWAY IN THE TOWN OF NORTH CANAAN.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (*Effective from passage*) (a) Notwithstanding any provision
- 2 of the general statutes, the Commissioner of Transportation shall convey
- 3 to the town of North Canaan four parcels of land located in the town of
- 4 North Canaan, at a cost equal to the fair market value of the property,
- 5 as determined by the average of the appraisals of two independent
- 6 appraisers selected by the commissioner, plus the administrative costs
- 7 of making such conveyance. Said parcels of land have a total area of
- 8 approximately 27.45 acres and are identified as "Release Area=27.45
- 9 Acres" on a map entitled "Compilation Plan, Town of North Canaan,
- 10 Map Showing Land Released to ___, By The State of Connecticut,
- 11 Department of Transportation, U.S. Route 7 (Ashley Falls Road) &
- 12 Granger Lane, Scale 1"-120', October 2021, Scott A. Hill, P.E., Chief
- 13 Engineer Bureau of Engineering and Construction" and are further
- 14 identified as all or a portion of Lots 041-0, 048-0 and 049-0 on town of

15 North Canaan's Tax Assessor's Map 29 and all or a portion of Lot 330-0
 16 on town of North Canaan's Tax Assessor's Map 22. The conveyance shall
 17 be subject to the approval of the State Properties Review Board.

18 (b) The State Properties Review Board shall complete its review of the
 19 conveyance of said parcels of land not later than thirty days after it
 20 receives a proposed agreement from the Department of Transportation.
 21 The land shall remain under the care and control of said department
 22 until a conveyance is made in accordance with the provisions of this
 23 section. The State Treasurer shall execute and deliver any deed or
 24 instrument necessary for a conveyance under this section. The
 25 Commissioner of Transportation shall have the sole responsibility for all
 26 other incidents of such conveyance. Any funds received by said
 27 department from a sale of said parcel in accordance with this section
 28 shall be transferred to the State Treasurer for deposit in the Special
 29 Transportation Fund.

This act shall take effect as follows and shall amend the following sections:

Explanation

The bill conveys specified parcels of land, totaling 27.45 acres, from the Department of Transportation to the town of North Canaan. The state would lose use of the asset and gain revenues equal to the fair market value of the property. The town of North Canaan would gain use of an asset and would pay fair market value of the property and the administrative costs of the conveyance.

The land conveyance is subject to the review and approval of the State Properties Review Board.

The Out Years

The conveyance action is one time in nature. Control of the asset would continue into the future as described above.
