***"AN ACT ESTABLISHING AN INTERAGENCY COUNCIL ON HOMELESSNESS."***

1 Strike lines 5 to 14, inclusive, in their entirety and substitute the  
2 following in lieu thereof:

3 "(b) The council shall consist of the following regular members:

4 (1) Two appointed by the president pro tempore of the Senate, one of  
5 whom is an individual who is experiencing or has experienced  
6 homelessness and one of whom is a representative of a continuum of  
7 care organization;

8 (2) Two appointed by the speaker of the House of Representatives,  
9 one of whom is a representative of an organization that advocates for  
10 victims of domestic violence or domestic violence prevention and one  
11 of whom is a representative of an organization that provides shelters or  
12 housing for individuals experiencing homelessness;

13 (3) One appointed by the majority leader of the Senate, who is a

14 representative of a public housing authority;

15 (4) One appointed by the majority leader of the House of  
16 Representatives, who has expertise in mental health or addiction  
17 treatment;

18 (5) Two appointed by the minority leader of the Senate, one of whom  
19 is a representative of local government and one of whom is a  
20 representative of a philanthropic organization;

21 (6) Two appointed by the minority leader of the House of  
22 Representatives, one of whom is a representative of a faith-based  
23 organization and one of whom is a representative of a group that  
24 advocates for housing developers;

25 (7) Two appointed by the Commissioner of Housing;

26 (8) The Commissioner of Housing, or the commissioner's designee;

27 (9) The Commissioner of Aging and Disability Services, or the  
28 commissioner's designee;

29 (10) The Commissioner of Children and Families, or the  
30 commissioner's designee;

31 (11) The Commissioner of Correction, or the commissioner's  
32 designee;

33 (12) The Labor Commissioner, or the commissioner's designee;

34 (13) The Commissioner of Mental Health and Addiction Services, or  
35 the commissioner's designee;

36 (14) The Commissioner of Social Services, or the commissioner's  
37 designee;

38 (15) The Commissioner of Veterans Affairs, or the commissioner's  
39 designee;

40       (16) The Secretary of the Office of Policy and Management, or the  
41       secretary's designee;

42       (17) The executive director of the Court Support Services Division of  
43       the Judicial Department, or the executive director's designee;

44       (18) The executive director of the Office of Health Strategy, or the  
45       executive director's designee;

46       (19) The chief executive officer of the Connecticut Housing Finance  
47       Authority, or the chief executive officer's designee; and

48       (20) The Long-Term Care Ombudsman."
