**"AN ACT RENAMING THE COMMUNITY INVESTMENT ACCOUNT  
THE DONALD E. WILLIAMS, JR. COMMUNITY INVESTMENT  
ACCOUNT AND INCREASING FUNDING FOR SAID ACCOUNT."**

1 After the last section, add the following and renumber sections and  
2 internal references accordingly:

3 "Sec. 501. Section 2-24 of the general statutes is repealed and the  
4 following is substituted in lieu thereof (*Effective October 1, 2025*):

5 (a) The words "State of Connecticut" shall be printed at the head of  
6 each bill and document printed by order of the General Assembly, or  
7 either house thereof, and on its title page or cover, if any. Before printed,  
8 electronic or photographic copies of an original bill are made, the bill  
9 shall be endorsed with (1) the date of its introduction; (2) its number; (3)  
10 the name of the member or committee introducing it; and (4) the name  
11 of the committee to which it was referred.

12 (b) Copies of bills or resolutions printed or produced electronically  
13 after favorable report by a committee or reprinted or produced

14 electronically after amendment on the third reading, i.e., files, shall bear  
15 the file number of such bill or resolution, placed conspicuously at the  
16 head of the same, which file number shall be assigned by the Legislative  
17 Commissioners' Office in the order printed or produced, the number  
18 and title of the bill, the name of the committee to which it was referred,  
19 the date and nature of the committee's report, in any case where the bill,  
20 if passed, would require the expenditure of state or municipal funds or  
21 affect state or municipal revenue, a fiscal note, including an estimate of  
22 the cost or of the revenue impact shall be appended thereto, and, in any  
23 case where the bill, if passed, would have a financial impact on electric  
24 ratepayers, a ratepayer impact statement, as described in subsection (b)  
25 of section 2-24a. When a bill or resolution is accompanied with a report  
26 of a committee, other than a recommendation that it ought or ought not  
27 to pass, it shall then have an additional endorsement, as follows:  
28 "Accompanied by special report, No.-". Bills shall be designated in the  
29 calendar of each house by their file numbers, as well as by the titles and  
30 numbers of the bills.

31 (c) No bill shall have a title containing the name of a lobbyist, as  
32 defined in section 1-91. "

This act shall take effect as follows and shall amend the following sections:
