"AN ACT CONCERNING MEDICAID COVERAGE FOR DIABETES PREVENTION, EDUCATION, SELF-MANAGEMENT AND MEDICAL NUTRITION THERAPY PROGRAMS AND ESTABLISHING AN ADVISORY COUNCIL."

1 Strike section 2 in its entirety and insert the following in lieu thereof:

"Sec. 2. (NEW) (*Effective from passage*) (a) There is established a
Diabetes Advisory Council to study and make recommendations
concerning diabetes education, prevention and treatment.

5 (b) The council shall consist of the following members:

6 (1) One appointed by the speaker of the House of Representatives,7 who has medical expertise in the treatment of diabetes;

8 (2) One appointed by the president pro tempore of the Senate, who
9 has expertise in educational and nutritional programs to help prevent
10 type 2 diabetes;

11 (3) One appointed by the majority leader of the House of

17 18	(7) The Commissioner of Social Services, or the commissioner's designee;
19 20	(8) The Commissioner of Public Health, or the commissioner's designee;
21 22 23 24	(9) A person diagnosed with prediabetes, appointed by the Senate chairperson and the House chairperson of the joint standing committee of the General Assembly having cognizance of matters relating to human services; and
25 26 27 28	(10) A person diagnosed with diabetes, appointed by the Senate ranking member and the House ranking member of the joint standing committee of the General Assembly having cognizance of matters relating to human services.
29 30 31	(c) Any member of the council appointed under subdivision (1), (2), (3), (4), (5), (6), (9) or (10) of subsection (b) of this section may be a member of the General Assembly.
32 33 34	(d) All initial appointments to the council shall be made not later than thirty days after the effective date of this section. Any vacancy shall be filled by the appointing authority.
35 36 37 38 39	(e) The speaker of the House of Representatives and the president pro tempore of the Senate shall select the chairpersons of the council from among the members of the council. Such chairpersons shall schedule the first meeting of the council, which shall be held not later than sixty days after the effective date of this section.

40	(f) The administrative staff of the joint standing committee of the

42	services shall serve as administrative staff of the council.
43 44 45 46 47	(g) Not later than July 1, 2026, and annually thereafter, the council shall submit a report on its findings and recommendations to the joint standing committees of the General Assembly having cognizance of matters relating to human services and public health, in accordance with the provisions of section 11-4a of the general statutes."
