REASONS FOR BILL:

HB-5283 will authorize municipalities to prohibit the sale of certain animals in pet shops. It was introduced to promote animal welfare and allow municipalities to have the ability to regulate pet shops in a safe way.

This bill was introduced to give local control to municipalities which is necessary in discouraging puppy mills and protecting animals, consumers, and public health. It addresses issues with negligence and is a critical step in reducing animal suffering.

NATURE AND SOURCES OF OPPOSITION:

813 people anonymously: oppose HB-5283 because they believe there are already enough regulations on pet stores to ensure safety and health within said operations.

[A-Z Pet Shop Associate Elijah A](#) opposes this bill as an employee at a local pet shop. While HB-5283 is well intentioned, it is misguided and will harm regularly inspected and safely regulated pet shops in Connecticut.
