**"AN ACT CONCERNING WORKFORCE DEVELOPMENT AND WORKING CONDITIONS IN THE STATE."**

1 Strike section 64 in its entirety and insert the following in lieu thereof:

2 "Sec. 64. (NEW) (*Effective from passage*) (a) Notwithstanding any  
3 provision of title 26 of the general statutes, any food service  
4 establishment that is regulated pursuant to the Public Health Code may  
5 sell to consumers any lobster greater than the Atlantic States Marine  
6 Fisheries Commission's American Lobster Fishery Management Plan  
7 Lobster Management Area 6 maximum legal length, as well as any  
8 lobster that is less than the Atlantic States Marine Fisheries  
9 Commission's American Lobster Fishery Management Plan Lobster  
10 Management Area 6 minimum legal length, as defined in regulations  
11 adopted pursuant to section 26-157c of the general statutes, provided:  
12 (1) Such lobster is not taken from such Lobster Management Area 6  
13 waters or landed in this state, regardless of where such lobsters were  
14 taken, (2) such lobster is not greater than the maximum legal length or  
15 less than the minimum legal length in effect for the applicable waters of

16 the Atlantic States Marine Fisheries Commission's American Lobster  
17 Fishery Management Plan Lobster Management Area, or the nation of  
18 origin, as applicable, and (3) such food service establishment in  
19 possession of such lobsters possesses a manifest, bill of landing, invoice,  
20 purchase order or other written documentation that identifies the state,  
21 lobster management area or nation of origin, as applicable, where such  
22 lobster was received, and the number of such lobsters received. Such  
23 documentation shall be retained by the food service establishment for a  
24 period of six months from the date such lobsters were received by such  
25 food service establishment and shall be made available to any law  
26 enforcement officer upon request.

27 (b) Notwithstanding the provisions of section 26-157j of the general  
28 statutes, any person licensed as a seafood dealer, pursuant to section 26-  
29 142a of the general statutes, may sell to a food service establishment that  
30 is regulated pursuant to the Public Health Code any such lobster, as  
31 described in subsection (a) of this section, provided such lobster  
32 complies with the provisions of subdivisions (1) and (2) of said  
33 subsection. Such seafood dealer shall provide to the purchasing food  
34 service establishment, at the time of sale, the documentation described  
35 in subdivision (3) of subsection (a) of this section.

36 (c) Any food service establishment that is regulated pursuant to the  
37 Public Health Code that offers any such lobsters, as described in  
38 subsection (a) of this section, for sale to consumers shall disclose the  
39 state from which such lobster was taken or, if such lobster was taken  
40 from outside of the United States, the country from which such lobster  
41 was taken."
