JJPOC Cross-Agency Data Sharing Work Group Monday May 18th, 2020 9:30-10:30AM Zoom Conference Call

Meeting Summary:

- 1. JJPOC Update
 - TYJI summarized updates from Executive Committee meeting, which can also be found on the CGA website. Attendance from the most recent meeting held on April 3rd included the JJPOC workgroup co-chairs. DOC, Judicial, DCF, community-based providers, and SDE. Relevant reports and updates of their organizations' response plans to COVID-19 were provided. TYJI plans on reconvening all JJPOC workgroups in May 2020. TYJI also plans on providing updated documents regarding response plans at the next JJPOC meeting (scheduled for May 21st).
 - CSG had their third IOYouth task force meeting on May 13th. They presented information on the deep end of system. The next meeting will be at the end of June/early July. Recommendations from CSG, in collaboration with agencies, will be drafted then. CSG's contract officially ends in June, however, they will continue to work with CT to develop an action plan based on recommendations that are approved by the task force. Their presentation from the most recent task force meeting will be posted to the CGA website.
- 2. New Plans for Summer/Fall 2020
 - Changes being made by other workgroups:
 - i. Diversion workgroup is shifting their original plan to continue enhancing their 2020 recommendations (i.e. raising the minimum age) to prepare for 2021. The sub-committee will begin working on the specific plan for implementation of raising the minimum age. The FWSN subgroup also continues to meet.
 - ii. RED workgroup does not have specific plan yet, but they discussed how the pandemic is impacting minority groups and how JJPOC may be able to help support these communities.
 - iii. Incarceration workgroup meeting is June 29th.
 - iv. Education committee meeting is this Friday and they will most likely continue to enhance their recommendations of a DCF oversight body for 2021.
 - There was discussion on focusing research on COVID-19 measures or sticking to regular measures the group has been focusing on, in preparation for their November 2020 JJPOC presentation.
 - There was discussion on continuing to monitor work of the other groups to see how the Data workgroup can support them.
 - There was a discussion on looking at youth who were already engaged in services, who may not be receiving those services anymore. A suggestion was made to potentially look

into the availability of technology and how it is impacting telehealth. There is also potential to look at treatment information through CSSD.

3. Check-In

- TYJI is still fully operating remotely and open to any question or suggestions moving forward.
- TYJI and OPM will check-in with the JJPOC co-chairs to get more guidance on the November 2020 JJPOC presentation and what data they would like to see.
