Meeting Summary

1. Update on the 2 bills in legislature

- JJPOC voted on recommendation in January and February
- Suspension expulsion recommendation has become Senate Bill 1093 which is moving through the education committee
- House Bill 6888 are recommendations from the remaining workgroups and subgroups of the JJPOC, coming from the Diversion workgroup
- Recommendation from the incarceration work group concerning reentry and commissary
- Recommendations from the community expertise work group regarding someone directly impacted from the youth justice system as voting members in the Statue to the JJPOC
- Two bills coming out of the JJPOC
 - One bill will be moving through the House once it moved out of the Judiciary Committee
 - second bill, suspension expulsion, will be moving through the Senate, currently moving through the Education Committee

2. Annual Work Plan Review

- Discussed Annual Report
 - Data within the JJPOC
 - Update annual report will be documented like current events, additional discourse that occurs in the meetings
 - Annual report should be present at JJPOC meetings throughout the year
- Equity Dashboard Update
 - 4 years of data now for the delinquent referrals, will be able to look at the town level
 - Fixed the protection of identity issue



- In delinquent referrals date they plan on rolling out 3 prioritized measures which is non judicial handling, first time felony, and dispositions in detention
- Looking for ways to present smaller data while dealing with identification issues
- Using dashboard for fall annual report and using that dashboard as a one stop shop for all juvenile justice data
- Question asked about next steps
 - Next measure is working on how to present first time felony dispositions
 - Along with how to present data in an appropriate way
- Support JJPOC Related Research
 - Related to all of Dr. Coopers work, who was not at the meeting to share updates
- Support Workgroup Data Requests
 - Making sure everyone is able to create policy that's based on data driven and evidenced based research

3. Agency Spotlight Discussion and Prep

- State Department of LED next month, DOC and DCF for July and September
- Start working with court support services to identify a provider for the may presentation
- Regarding the nonprofit presentation JJPOC is thinking of the array of diverse providers that can be included
- This could either be JRB or YSB
- Planning on inviting the non-profit alliance
- Question: "What information do we want them to provide?"
- Identifying a large program model that serves a lot of kids, talk about it as an educational piece, and talk about program outcomes and some of the challenges they are having
- Asking the providers what they see out on the front lines, challenges at the deep end and in the front end of the system
- Discussion on Truancy questions that might be presented in the presentation
- DOC will be reporting on education, use of restraints, isolation and chemical agents
- JJPOC will give feedback from the last presentation on what they want to see more or less of
- Dr. Worthy and his team will present at the Education Work Group as a dry run
- Having the spotlights and having them planned out ahead of time helps state agencies have enough time to prepare for those questions
