#### **Meeting Summary**

## 1. Brittany LaMarr covered 2024 JJPOC Recommendations:

- 3 work groups presented recommendations: Education Workgroup, Incarceration Workgroup, Gender Responsiveness Workgroup.
- Gender Responsiveness Work Group Recommendations: Create the workgroup, the type of work it would conduct, landscape analysis conducted on gender responsiveness in the state, potential policy recommendations, gap needs assessment performed. Need to look at how our programs are tailored to the needs of those they are serving.
- Reentry Subgroup: Create a reentry success plan with collaboration from multiple state agencies. Expand use of credible messengers, give youth access to credible messengers for a longer period or mentorship program. Allow Reentry Subgroup to continue to work on pieces of plan: quality assurance and funding framework. Ensure that youth were provided the opportunity to participate in a work certified or job readiness program prior to release.
- Education Workgroup: Public and vocation institutions cannot ask young people about disciplinary history for the purpose of admission into an academic program. Doesn't include criminal history, includes suspension or expulsion.
- All three of these passed.

- 5. Brittany LaMarr said JJPOC is working on a guide for using the dashboard in more plain language to make it easier to navigate.
  - Maurice Reaves added they want more public awareness of the dashboard to increase website traffic.
  - Overall focus on getting more individuals to engage with dashboard site.
