 - The goals of this Certificate Program are to promote an ongoing engagement in school among youth at risk, partner effectively across child-serving systems, develop diversion programs and disrupt school-justice pathways, and improve academic outcomes for all students.

• Capstone Goals

- Identify where school-based diversion is happening in the state, what it looks like & engage key stakeholders to gain buy-in for school-based diversion, based on the JJPOC Diversion Workgroups "Development of a School-Based Diversion System in Connecticut"
- Current task: Defining School-Based Diversion
 - Overall goals
 - Assess middle and high schools for SBD efforts
 - Diffuse information to key stakeholders to gain engagement
 - Present on the process and outcomes to the JJPOC
 - Current task (defining school-based diversion)- To start, need to identify our working definition for what SBD means
 - JJPOC framework: "a plan for school-based diversion initiatives to reduce juvenile justice involvement among children with mental health needs in schools with high rates of school-based arrests, disproportionate minority contact and a high number of juvenile justice referrals." These are the outcome goals, but not specifically what SBD is.

 - What is Diversion in general, from your perspective?
 - What is *School-Based* Diversion, from your perspective?

- Are there any programs or practices that you know about happening in CT that you think qualify as school-based diversion?
- Are there any criteria that either automatically include or exclude work from schoolbased diversion? (ex: diversion happening out in the community by police is not SBD, because it is not happening on school grounds)
- Is there anyone else we should ask these questions to?
- Is there anything else you would like to say about school-based diversion, or any questions you have for us about our capstone project?
