- 3. Update on legislation
 - Nothing moved forward that we wanted, we have a lot of information in place for next year.
 - We can build on for next year, we have a report due in January for the next set of charges to include
 - Roll into one larger package and make their effective dates pushed out so we are not asking for everything all at once.
 - HB 5417, demonstrates power of perception, media, and election year
 - Breakdown of language of HB 5417, may be some residual impact with diversion. (Bring to next meeting or send out to workgroup members)
 - i. Sue is summarizing the changes that the bill does
 - Linda will summarize and bring/share HB 5001, it also has language on truancy
 - Some towns doing pre arrest diversion already, hb 5417 (5 day timeline) may encourage more referral for pre-arrest diversion

 - Truancy still pursuing the permission form for the beginning of the school year, Hartford would pilot it. Search of best practices and community based services

- Engage law enforcement, educate, informing, planning how that is going to be done. Educate and do outreach on multiple topics. Include pre-arrest diversion and others, who are the stakeholders, what are the messages
