Story behind the baseline:

The program engages artists from every corner of the State and it reaches a wide spectrum of participants; emerging artists, mid-career artists and master artists.

Trend Going in Right Direction:

There has been consistency over the years with fluctuation between the various disciplines. Each year COA evaluates the disciplines offered (and not offered) and strives to align them with the needs of the field.

Story behind the baseline:

The program is highly competitive due to the large number of applicants, the available funds, along with the rigorous panel review process.

Funding is limited only to the top scoring applicants. All applicants are reviewed by peer professional panelists who are experts in the designated disciplines.

Trend Going in the Right Direction:

The award remains prestigious, yet the number of awards makes it possible for fairly widespread support of the field.

Story behind the baseline:

Fellowship funding is awarded, not requested by applicants. The program offers two (2) awards, one at \$2,500 and the other at \$5,000.

Panelists review the applications which include work samples and make recommendations based on the quality of the work. In addition, artists must demonstrate their ability to continue to make new work if awarded.

Trend Going in the Right Direction:

Panelists make award level recommendations as part of their review. COA is currently revising size of the awards to better align with national trends along with required support of the field.

Is Anyone Better Off? Arts Economy / Job Creation

Statistics captured in Testimonials.

Award = Funding & Recognition for CT Artists Funding = Ability for Artists to produce new work, employ others and support the arts industry.

The funds impact the careers of the artists and in many cases the funding allows the artists to employ others. For example; Choreographers hire dancers, Playwrights hire actors, Music Composers hire musicians, Visual artists hire studio assistants and Filmmakers hire actors.

Story behind the baseline

Testimonials are a significant part of the final report process for the Artist Fellowship program. These testimonials capture and convey the use of the funds along with the impact but unfortunately they cannot provide this information in statistical charts.

COA is looking at ways to redesign the Final Reports to include a greater focus on capturing raw data from artists which will highlight the significance the grant plays on their ability to advance their careers, employ others and therefore, impacting job creation and the arts economy.

This small award is often the starter fuel to the fire and from there the recipient is able to sustain the energy to complete the work and engage others in the process.

Trend Going in the Right Direction:

There is more work to do to track the impact of Fellowship dollars. There is evidence in the testimonials collected but raw data is necessary to better illustrate the success.

Story behind the baseline:

The strength of the program is with its competitive nature. Applicants must present a strong portfolio of work and demonstrate the ability to continue to create great works of art.

Trend Going in the Right Direction:

To be meaningful and worthwhile to the applicants, it is important to continue with the rigorous panel process with limited awardees.

Proposed actions to turn the curve:

The Artist Fellowship program strives to consistently reevaluate the categories offered, the submission requirements, the number of grants awarded and the dollar value per grant. As the arts change around us, we must also adjust the program to better serve the artists here in Connecticut. Increasing the Significance of the Award

- COA will be shifting to even fewer but larger Fellowship Awards thus elevating the stature of the award and providing greater impact on the career of the artists.
- The award will carry more prestige for those who are awarded a *Connecticut Artist Fellowship*.
- Awards will be distributed at the Governor's Arts Awards bringing greater attention to the significant role these artists play in CT. Therefore, the program will not administer funds in FY13 and will resume in FY14.

Continuing and Enhancing our Partnerships

- Partners help to reach new artists who may not be familiar with the program.
- The program engages recent graduates and several emerging artists have received recognition through the program. The program, in part, provides these young talented artists with an incentive to remain in Connecticut and to become part of the arts economy of the State.
