Non-State fund employees are paid from tuition, fees, research, clinical and other self-generated revenues.

- There are no vacant positions on the General Fund. UConn/UConn Health fully appropriates the general fund by salary, not by headcount.
- At UConn Health non-general fund vacant position budgets are being used for temporary agency staff and overtime to cover clinical needs.



### **UConn/UConn Health: Contracts**

- There are service contracts at UConn with a total value of \$167M and at UConn Health with a total value of \$107M.
- The types of contracted services range from custodial and landscaping contracts to security services at select clinics.

### **UConn/UConn Health: Revenues**

State support accounts for 26% of revenues at both UConn and UConn Health.



UCONN

Auxiliary = Housing, dining, athletics, health services, etc. Other = Sales and service revenue, study abroad, gifts/endowments, etc. Other = Auxiliary services, gifts/endowments, external contract revenue and internal income (offset by internal expense)

### UConn/UConn Health: Budget Request

- UConn and UConn Health requested a total of \$1B from the state. The state covers approximately 26% of our budget.
- The university is requesting permanent funding to cover the SEBAC Collective Bargaining Increases (CBI) and legacy costs.
- In FY23, the University requested the same thing permanent funding to cover the SEBAC CBI and legacy costs. The final budget provided one time federal ARPA funding.
- With respect to the fringe benefit proposal, the change may have a positive impact on our ability to be more competitive as it relates to securing more federal research grants, it will increase the amount the state covers for fringe benefits by \$60M, but it simultaneously reduces the block grant/state support for salary needs by \$60M to create a net budget neutral situation for the state.
- Overall, the difference between our request and the Governor's budget is \$159.6M in FY24 and \$197.1M in FY25.

The shortfall noted on the charts (\$156.3M in FY24 and \$195.6M in FY25) represents the remaining amount needed to cover the operating portion of the request.

### UConn/UConn Health: Budget History

The baseline has been growing to cover some CBI costs, but we are requesting that funding be provided to cover the ongoing legacy and all CBI costs.

### UConn/UConn Health: ARPA

Is UConn/UConn Health requesting any state support specifically to offset the decrease in ARPA?

- UConn/UConn Health's request last and this year is based on a cash shortfall that are in two areas:
  - The ongoing financial impact of the negotiated statewide collective bargaining increases
  - The ongoing legacy costs.
- The state made the decision to provide ARPA funds last year to support operations at UConn/UConn Health.
- With OPM's guidance and approval, the university used the ARPA funds for authorized/allowable costs.
- The fact the ARPA funds were one-time in nature was well-understood by all parties last year as the state budget was finalized and enacted.
- UConn/UConn Health's request for the biennium is for the state to pay for the ongoing costs of the SEBAC agreement for all our employees and cover the unfunded legacy costs, just as the state covers these costs for every other state agency.
- We are not requesting any ARPA funds; our request is for the state to cover the shortfalls associated with the commitments the state made with respect to SEBAC and the legacy fringe costs and for this relief to be permanently added to the block grant.

# UConn/UConn Health: ARPA

How has UConn spent the ARPA funding it has received?

How does UConn plan to spend any unspent ARPA funding it has received over the biennium?

- UConn/UConn Health have allocated all ARPA funds in FY23.
- Due to the strict guidelines on use of federal ARPA funds, and with OPM's guidance, the university utilized the ARPA dollars as follows.

### Storrs:

- \$33.2M of ARPA funds were utilized for operations in Facilities and University Safety;
- \$5M was utilized for partial operations in housing/dining and both will be spent by year end.
- \$1M of legislatively directed projects (Social Media Impact study and Puerto Rican Initiative) will be spent by the end of FY24.

• \$72.7M of ARPA funds were utilized to support the multispecialty physician practice salaries and will be spent by year end. These funds allowed UConn Health to continue to support patient access needs of the State of CT without cutting any programs.

# UConn/UConn Health: Combining Block Grant

What are the drawbacks of combining the UConn/UConn Health block grant?

- UConn/UConn Health believes in and has been practicing a "One UConn" model for years with respect to shared services between campuses to reduce costs, but combining the two budgets threatens to create situations and scenarios where UConn is urged or mandated to use funds generated by and intended for the Storrs and regional campuses to, for example, fund unrelated costs at UConn Health in Farmington, or vice versa.
- We have been working for years and have been successful in gaining operational efficiencies between UConn and UConn Health and will continue to do so. Some examples include University Safety, Research, and Compliance.
- A combined budget does not provide transparency in tracking Legislative intent of allocations.
- We would ask that UConn and UConn Health remain as two separate budgeted line items.



### **UConn/UConn Health: Fringe Proposal Impact**

Why does this Fringe/legacy arrangement not work for UConn?

- The proposal increases the amount the state covers for fringe benefits by \$60M and simultaneously reduces the block grant/state support for salary needs by \$60M to create a net budget neutral situation for the state.
- While the change could have a positive impact on our ability to be more competitive as it relates to securing more federal research grants, it does not provide fiscal benefit/relief to the university overall.
- UConn/UCH shortfall would be unchanged for FY24 and FY25 under this proposal and we are still requesting overall fringe cost relief.



# **Governor's Fringe Proposal**

**Proposal:** State would fund all retirement costs and University would fund all other non-retirement fringe costs (Group Life, Medical insurance, Unemployment, FICA, Medicare)

### Current Fringe Methodology:

UCONN

- All employee fringe components are charged as an expense to the University (\$673.2M Total Fringe Benefit expense)
- For Block Grant funded employees, the fringe benefit expenses are reimbursed via in-kind fringe (\$359.4M State Supported Share)
- For non-Block Grant employees, the University covers these fringe benefit expenses using their own funds (\$313.7M University supported share)

### Proposed Fringe Methodology:

- Non-Retirement fringe costs for all employees will be the University's financial responsibility (\$253.4M Non-Retirement Fringe Benefit expense)
- Retirement fringe costs will be covered by the State for all employees (\$419.8M Retirement Fringe Benefit expense)
- Impact will be an <u>increase</u> to State Share of Fringes by \$60.4M
- To keep Impact neutral to the State Budget, a <u>decrease</u> to the block grant of **\$60.4M** is proposed

# **UConn: Budget Shortfall – Tuition & Enrollment**

### Equivalent actions required to fill the shortfall between the requested and Governor proposed budget:

- A \$3,000 tuition increase per undergraduate and graduate student. (That equates to a 19% increase for in-state undergraduates).
- An increase of out-of-state enrollment by 3,732 students (while decreasing 3,732 in-state students.
  - That means 40% fewer in-state students would be offered admission to UConn Storrs per year.
  - The residency mix would change from 72% to 57% in-state students. This would be an immediate and permanent change in our approach to admissions that would severely disadvantage in-state students.

# **UConn: Demographic Profile of Enrollment - Statistics**

**First Generation Students**: Increased by 11 percentage points (37% in Fall 2022) over the past eight years.

**Pell Recipients:** Increased by 4 percentage points (28% in Fall 2022) over the past eight years.

**Underrepresented minority students:** Increased by 12 percentage points (currently 28%).

**Total minority enrollment:** Increased by 18 percentage points (currently 46%).

- Hispanic /Latino enrollment has more than doubled.
- Enrollment of Black/African American students has increased by 42%.

### **UConn: XL Center**

What are the costs and revenue gain (if any) associated with UConn games played at the XL Center?

- UConn men's and women's basketball have competed in the XL Center since 1975. More recently, UConn men's ice hockey has also competed in the XL Center since it joined Hockey East in 2014. Arrangements to play in this facility are currently managed by the CRDA, and cost UConn approximately \$50K per game. The net revenue gain is dependent upon the number of tickets sold for each game. In FY22, UConn had an average per game gain of about \$283K from XL Center basketball games.
