Community Providers Perspective on Juvenile Justice System Needs

T YOUTH JUSTICE INSTITUTE

- Connecticut Junior Republic (CJR) is a private nonprofit agency whose mission is:
 - To provide care, treatment, education and family support for at-risk, special needs and troubled young people so they can become
 productive and fulfilled members of their communities.

Programs and Services:

- Residential Programs: Litchfield Residential, East Hartford and Winchester Group Home
- Community-based programs located in Danbury, East Hartford, Middletown/Meriden, New Britain, New Haven, Rockville/Manchester, Torrington, Waterbury
- Behavioral Health & Wellness Programs
- Vocational and Educational Programs

2015-2016 Outcomes:

- 2,615 young people and their families received services through CJR
- 81% of the youth served by CJR's New Britain A-CRA substance abuse treatment program completed services successfully
- 87% of the youth discharged from New Britain-based Fostering Responsibility Education and Employment (FREE) Program
 completed services successfully.
- Torrington Child, Youth and Family Support Centers (CYFSC) served 140 children and families and had service completion rate of 91%
- 96% of the girls admitted to CARE (Community Residential Program) completed services successfully and were referred to the appropriate level of aftercare in their home communities
- 85% increase in number of children and families receiving services in the Wellness Center
- The Cable Academic and Vocational Center had a 92% average daily attendance rate, served students from 59 towns and school districts of this total 40 were represented by day students.

Community Providers Perspective on Juvenile Justice System Needs



LISA, Inc. is a private nonprofit agency whose mission is:

To provide safe, supporting, empowering programs that build skills, awaken hope for the future, and help young people successfully transition into adulthood.

Programs:

- Residential
 - Lisa's Wish; 8-bed SWEPT program girls age 17-21 in Plainville
 - ⁻ SAIL Program; 12-unit TLAP program for young men and women age 18-23 in Bristol.
- Community Based Life Skills (CBLS); youth 14-21, statewide.
- Youth Excellence Program; 13-17 year old boys leadership program statewide.
- DST prevention and intervention groups for girls age 14-21

System Service Gaps




- Integrated treatment

- Wraparound support
- Access to supplemental services
- Education options
- Independent living skills
- Vocational and employability skills
- Intermediate, short term, residential treatment options
- Step-down program options


System Recommendations



- 1. Integrate current diversion services into a formalized system
- 2. Establish innovative funding structures to encourage a public/private partnership
- 3. If the system remains bifurcated, identify a provider to provide care coordination.
- 4. Pilot the preferred service delivery system in one geographic area or region
 - Design, fund, and implement in one location
 - Identify a "lead provider" or coalition to lead activities
 - The system would include services for all levels of youth in JJ and at high risk for delinquency.
 - Replicate; but only after all processes and services are proven effective
