| Re: | Truancy Referral for Community Based Services: A Guide for Parents/Guardians |

Attached you will find the finalized parent guide entitled: "Truancy Referral for Community Based Services: A Guide for Parents/Guardians".

This guide was created by the Truancy subgroup of the Diversion Work Group as a way to help parents understand:

- The importance of school attendance for their children;
- Their legal responsibilities for school attendance;
- The school's role in supporting the family;
- The referral process for community-based services; and
- What services they could receive from a Youth Service Bureau (YSB) after a truancy referral.

The Truancy subgroup worked diligently over the last year to create a simple, yet informative guide to begin to support the education of the truancy referral process for parents/guardians. ***The Truancy subgroup is asking YSBs to:**

- Distribute this Guide to their school contacts so they can hand out to parents/guardians;
- Distribute them to the parents/guardians the YSB works with;
- Forward them to all of their partners locally and regionally (with a focus on partner agencies that serve families) for distribution to the families they work with; and
- Distribute to local police departments.

The more widespread the distribution, the more likely we are as a system to get them into the hands of the families we serve and create a better understanding of the importance of school attendance and the larger truancy process. Please also use the release of this guide as an opportunity to re-engage with your schools regarding Truancy and the support you, as a YSB, can provide.

*INSTRUCTION FOR INTERNAL USE/DISTRIBUTION TO LOCAL ENTITIES:

1. Prior to printing or distributing, please review the back of the guide where CYSA is listed under "Contact Information". **Each YSB should replace this with their individual contact information** so families in your area know who to contact.

*INSTRUCTIONS FOR DISTRIBUTION OUTSIDE OF YOUR COMMUNITY OR TO REGIONAL PARTNERS:

- If you are distributing the guide to regional providers or others who may serve families from a variety of towns, the CYSA contact information can remain on the back of the guide. Parents/Guardians will be able to find contact information for their local YSB on the CYSA website.
- 2. Each YSB will need to forward this brochure on to its partners, as well as print copies for distribution. It needs to be printed as a two-sided document so it can be folded into a tri-fold brochure.
