Waiver For Persons With Autism (Lifespan Waiver)

The Department of Social Services' waiver for persons with autism provides home-and community-based services to individuals with autism who do not have an intellectual disability (individuals must have a full IQ score of 70 or higher). Individuals must have substantial limitations in two or more of the following major life activities: (1) self-care, (2) understanding and use of language, (3) learning, (4) mobility, (5) selfdirection, or (6) capacity for independent living.

Services provided under the waiver include:

- Behavioral Services
- Job Coaching
- Community Mentor
- Life Skills Coach
- Social Skills Group
- Respite (in-home and out-of-home)
- Assistive Technology
- ✤ Interpreter
- Specialized Driving Assessment
- Personal Emergency Response System
- Individual Goods and Service
- Non-Medical Transportation
- ✤ Nutrition

Active Autism Waiver Participants Info

- Maximum Waiver cap per person per year: \$50,000
- The average allotment in CY 2023 was \$25,498
- The waiver added 13 new providers in CY 2023, bringing the total number of providers to 151
- Since the transition of the waiver from DDS to DSS (2016), the waiver has grown from 3 case managers and 120 people receiving waiver services to 11 case managers and 330 people in the process of being determined Medicaid eligible or receiving waiver services
- The number of assigned cases will increase by 120 in July 2024

- 144 individuals with an application year of 2023 were found eligible for the autism waiver and were added to the waitlist
- As of 2/16/2024, there are 2,058 individuals on the waitlist; 101 are ages 5 and under
